## Announcement on distribution of healthcare items in canvassing for 2020 Multiparty Democracy General Election under containment measures against COVID-19

- 1. Hluttaw candidates for parliamentary elections need to follow the directives of National-Level Central Committee on Prevention, Control and Treatment of COVID-19, the Ministry of Health and Sports, the containment measures againt COVID-19 and the Standard Operating Procedures—SOP— in their canvassing for votes during the election campaign period.
- 2. It is not required for them to declare the election expenses for facemasks, face shields, hand sanitizers and gloves distributed by the Hluttaw candidates or the election agents to the voters during the campaigns with the limited number of participants inside the buildings and in public areas.
- 3. Except distribution of such items in the above-mentioned campaigns, the Hluttaw candidates and the election agents must declare the actual expenses paid from the fund for distribution of these items in other ways of campaigns.

# Myanmar repatriates nationals from abroad on relief flights

YANMAR embassy in Singapore organized a relief flight in bringing the nationals back home.

The 17<sup>th</sup> special flight of Myanmar National Airlines landed at Yangon International Airport with 148 citizens who were stranded in Singapore due to suspension of international flights.

A relief flight of Myanmar Airways International arranged by the Myanmar embassy in the Manila brought back 10 citizens in the Philippines and other 22 Myanmar seamen landed in the Philippines after they worked on the MV Alonissos of the Sea Traders S.A shipping company in Greece. The flight arrive in As they arrived in Yangon, officials from the Ministry of Labour, Immigration and Population, the Ministry of Health and Sports, and the Yangon Region government helped for their 21-day quarantine period in line with the regulations of immigration and medical checks.

For the repatriation of Myanmar citizens who were stranded in foreign countries by relief flights and chartered flights in accordance with the instructions from National-Level Central Committee on Coronavirus Disease 2019 (COVID-19), the Ministry of Foreign Affairs cooperated with the relevant ministries and Myanmar embassies from respective countries.—MNA

# Advice to people in Yangon Region

- 1. About 6,000 people have been quarantined in Yangon. Within two days, quarantine spaces were arranged for 1,000 people who came back from Rakhine State. Now, the number of people who had contacts with COVID-19 patients has increased, so seven new quarantine centres have been established for 1,000 more people. The civil society organizations and volunteers are invited to help the persons at the quarantine centres.
- 2. People in Yangon need to send the persons who had contacts with confirmed cases in the contact tracing to the quarantine centres without making them worried.
- 3. People should adhere to the required rules and regulations in the quarantine centres. When sending food to people in quarantine centres, alcohol and cigarettes should not be included in the delivery.
- 4. People in Yangon have lots of difficulties, challenges and burdens. Therefore, they need to strictly follow the rules by staying at home in two to three weeks during this period. In going outside for necessary reasons, they must wear masks. As Yangon City has a large number of population, people are also advised to abide by the rules of Ministry of Health and Sports amidst the increasing number of confirmed cases.

## Myanmar, ROK hold 1st Joint General (Trade) Working Committee Meeting

THE Republic of the Union of Myanmar and the Republic of Korea (ROK) organized 1st Joint General (Trade) Working Group Committee Meeting online via Zoom yesterday.

U Min Min, Director-General of Trade Department of Myanmar's Ministry of Commerce, and Mr Chun Yoon-jong, Director-General of Trade and Economic Cooperation Bureau of ROK's Ministry of Trade, Industry and Energy (MOTIE), co-chaired the meeting.

During the meeting, they said they would closely cooperate in establishing a common trade goal this year, and in promoting agricultural trade.

Myanmar representatives discussed assistances from ROK and ongoing cooperation in promoting bilateral trade and investments on producing value-added rubbers and foods and garment sector and, and ROK representatives replied that they would consider for providing assistance in future.

They detailed about close cooperation on establishment of Myanmar-Korea Apparel Testing Research Institute (MKATRI) and successful implementation of Technology Advice and Solutions from Korea (TASK). ROK representatives affirmed providing assistance for development of rubber industry. Director-General U Min Min highlighted MYANTRADE training and establishment of Korea Desk.

He also expressed thanks to ROK Government for providing assistance for strengthening the capacity of Myanmar Trade Promotion Organization (MYAN-TRADE) to promote bilateral trade between Myanmar and ROK and to send Myanmar products into international market. The meeting said the two nations would cooperate in launching Korea Desk which is a main road for bilateral economic cooperation to solve the economic difficulties of the two nations' businesses operating in both sides and to help the businesses smoothly get into market.

Orders issued by the Ministry of Commerce were distributed to foreign investors who will do businesses in Myanmar so that they can get trade opportunities.

Despite the first such meeting between the two countries, it is successful and beneficial for both nations discussing smoothly growing of bilateral trade and cooperation.

### Advance voting process for local voters outside their constituencies in 2020 General Election

- Heads of trainings, schools, hospitals and jails are to contact the sub-election commissions to get documents of Form 15.
- They must return these documents to sub-commission of respective townships by 26 August 2020 after the documents are filled by the voters.
- Sub-election commission of respective townships must send ballot papers and envelopes for advance voting to the trainings, schools, hospitals and jails by 7 October 2020.
- Advance voting must be organized at trainings, schools, hospitals and jails on their appropriate day from 8 October 2020 to 21 October 2020.
- The envelopes containing ballot papers must be sent back to sub-election commission of respective townships by 4 pm on 8 November 2020.

# Road Transport Administration Department suspends services

WITH permission from the Ministry of Transport and Communications, the Road Transport Administration Department will suspend services from all its offices in order to prevent and protect against the spread of

## Advice to people in Nay Pyi Taw

- 1. People should not illegally come to Nay Pyi Taw. If a person comes back from other places to Nay Pyi Taw, he/she needs to inform and receive medical examination. The charge for COVID-19 tests has been considerably reduced.
- 2. It has been learnt that some people get out of the cars on the Yangon-Mandalay Expressway and some old roads, and then they entered into Nay Pyi Taw via motorcycle roads and inter-village roads. So, authorities are cooperating with the Myanmar Police Force to take strict measures to control these illegal entries.
- 3. The ward/village administrators have been instructed to report, manage and send individuals who entered or came back to the ward/village to the quarantine centres.
- 4. To make the flow of goods smooth, truck drivers will be given the slip at the entrance gate. From the entrance gate, the drivers must drive their trucks directly to the exit gate, where the slip must be returned. The truck drivers are not allowed to go to other places between the entrance gate and the exit gate.
- 5. Face mask rule has been imposed in Nay Pyi Taw townships and COVID-19 awareness has been raised via loudspeakers. A dusk-to-dawn curfew has been in force, and surprise checks have been carried out on restaurants.

## 17th National Tripartite Dialogue Forum held via videoconferencing

THE Ministry of Labour, Immigration and Population, in collaboration with the International Labour Organization (ILO), organized the 17<sup>th</sup> National Tripartite Dialogue Forum (NTDF) through video conferencing which was taken part by the representatives of government, employers and employees yesterday afternoon.

Union Minister U Thein Swe and Deputy Minister U Myint Kyaing, ILO Liaison officer Mr Donglin Li and representatives from ILO Yangon office, representatives of employees and employers participated in the forum.

The forum aimed to work together to find ways to prevent the spread of COVID-19 disease in factories and to ensure the safety of workers.

The Union Minister said that although the discussions were focused on a labour-intensive region of Yangon, it would apply to factories, workplaces and industrial zones across the country and it would be implemented based on the findings of the discussion.

The Union Minister continued that 16th NTDF held on 23 June implemented the

COVID-19 Economic Recovery Plan (CERP) to overcome the COVID-19 crisis and the tripartite representatives agreed to cooperate in the New Normal practice that would result from COVID-19.

The ministry is implementing the four pillars of social work for the resolution—to revive the economic and employment sector based on the international labour standards in regard with the ILO's COVID-19 crisis response, to provide support to the businesses and employments for their incomes and to protect workers in the workplace.

The Ministry of Health and Sports released a letter on 12 August to prohibit gathering of more than 30 people; the Yangon Region government, with the close supervision of its Ministry of Immigration and the Human Resources, led control measures of COVID-19 in collaboration with officials from General Administration Department, Factory and General Labour Laws Inspection Department and the Health Department as the spread of this disease occurred in Rakhine State in mid-August.

The Union Minster said that he met with the business people of garment sector at UMFCCI office on 29 August and discussed to cooperate in conducting the disease control measures as the infection rate is high again. He called on all to work together for the development of the garment industry while the government eased some restrictions to create better environment for domestic and foreign investors to make investment.

He also met the representatives of Trade Unions at Hlinethaya Industrial Zone on 30 August and said the Ministry makes concerted efforts for maintaining job opportunities at factories, industries, shops and other workplaces, occupational safety, development of workers' skills, pleasant workplaces and to improve the foreign investment and discussed to find solutions for the economic impacts of COVID-19 at the factories and industries and to follow the health guidelines of the Ministry of Health and Sports without fail.

The meeting also discussed


the measures to be taken to reduce the risks to workers and employers due to the spread of COVID-19 in factories and industries, law amendment of labour affairs for future, labour rights and matters related to the employers including cooperation works with international organizations.

The ministry will keep monitoring on undergoing quarantine and medical treatment of employees and also study the orders of employers, investment and the future prospects regarding the changes in the neighbouring and the world countries.

It emphasizes to the attitudes and problems of employers and employees and urges them to work together to overcome this situation as quickly as possible with their self-discipline.

Then, ILO Liaison Officer Mr Donglin Li, the representatives of the employers and employees respectively delivered greeting speech and discussed COVID-19 control measures among the employees and future functions for employers, employees and the government.—MNA

## MoSWRR provides CERP cash assistance to PWDs, shelters in 9 regions/states

THE Ministry of Social Welfare, Relief and Resettlement held a virtual meeting to provide cash assistance to the persons with disability and the shelters in 9 regions/states yesterday morning.

Deputy Minister U Soe Aung made a discussion at the meeting.

Cash assistance is being given under the COVID-19 Economic Relief Plan to the PWDs, internally displaced persons, the elderly persons of the age between 80 and 85, the pregnant woman who are not included in the Maternal and Child Cash Transfer.

Under the CERP, a total of 1,809.870 million kyats for the 60,329 PWDs, and 270.840 million kyats for 228 shelters.

Each of senior citizens

and pregnant woman outside the MCCT plan have received 30,000 kyat.

The Deputy Minister also said that the civil service personnel need to work in providing cash assistance as it is aimed to support financial flow of the country.

Ministers from the region/ state governments, staff officers of region/state Social Welfare Department, members of PWD rights committee and responsible persons of the shelters.

The ministry has presented 17.505 million kyats to 21 shelters in Sagaing region and 17.250 million kyats to the 12 shelters in Taninthayi region on 10 September.—MNA

# Rails for Yangon-Mandalay track arrive in Myanmar

RAILS for upgrading Yan- () gon-Mandalay railway track

were unloaded at the Sule Jetty in Yangon yesterday morning. The 2,995.270 tonnes of 82-ft long rails were imported by a cargo shipment from the Tokyu Construction of Japan.

The rails have been imported by the 7 cargo vessels up to now and the remaining rails will be carried by the two vessels.

The rails were conveyed to the Ywar Thar Gyi dry port before sending to Ottwin Township which is close to the road section of Nyaunglebin-Taungoo Upgrade of Yangon-Mandalay railway will need a large value of investment, and that it is being implemented in tow phases. The first phase covers 166 mile long from Yangon to Taungoo, and the second phase is 219.5 miles from Taungoo to Mandalay.—Pwint Thitsar

## Over 900 curfew breakers nabbed nationwide within week

A total of 969 people -- 919 males and 50 females -- were charged under Penal Code Section 188 for violating curfew across the country during this week, according to Myanmar Police Force.

Police also arrested a total of 193 people from 11 KTV/Bars, 16 illegal massage parlors and 7 whorehouses in Nay Pyi Taw Council Area and in regions and states between 4 and 10 September for violating COVID-19 rules.

Among them, 3 are female sex workers from a whorehouse in Nay Pyi Taw Council Area; 6 are owners, managers, staff and massage parlour girls of a KTV and a massage parlour in Kachin State; 7 are owners, managers, staff and massage parlour girls of a KTV and an illegal massage parlour in Kayin State. Twenty-three are owners, managers, staff and sex workers of 2 KTV/Bars and 2 whorehouses in Sagaing Region; 7 are female sex workers from a whorehouse in Taninthayi Region; and 17 are owners, managers, staff and massage parlour girls of a KTV and 2 illegal massage parlours in Bago Region. Twenty-six are owners, managers, staff and massage parlour girls of a KTV and 2 illegal massage parlours in Magway Region; 7 are owners, massage parlour girls and sex workers of an illegal massage parlour and a whorehouse in Mandalay Region; and 12 are owners, managers, staff and massage parlour girls of 2 KTV/Bars and 2 illegal massage parlours in Mon State.

Fifteen are owners, managers, staff and massage parlour girls of 2 KTV/Bars and 6 illegal massage parlours in Yangon Region; 58 are owners, managers, staff, massage parlour girls and sex workers of a KTV, an illegal massage parlor and 2 whorehouses in Shan State; and 12 are owner, manager and staff of a KTV in Ayeyawady Region.

Police has been conducting law enforcement activities to take actions against illegal opening of KTV lounges, bars and illegal massage parlours without abiding by COVID-19 rules and to catch curfew breakers. Therefore, they urged the public to cooperate with them in the law enforcement process.—MNA (*Translated by Khine Thazin Han*)

## 224 Myanmar nationals come back home via Myawady border bridge on 11 Sept

A total of 224 Myanmar nationals returned home from Thailand through No.2 border bridge in Myawady Town, Kayin State, on 11 September.

Kayin State Hluttaw MP U Thant Zin Aung, Myawady District Administrative Officer U Tay Zar Aung, his deputy officer U Aung Nyein Chan, Police Lieutenant Colonel Pyae Sone and local officials helped the returnees with medical tests and other supplies.

The number of migrant workers who returned home from abroad through this border has been 76,425 until now.

Among 16 males and 14 females, 1 person was from Yangon Region, 1 from southern Shan State and 28 from northern Shan State.

They will go back to respective areas through Lashio with the arrangement from Chinshwehaw COVID-19 committee. A total of 15,072 persons have returned Myanmar from China through Chinshwehaw border crossing from 30 April to date.—Zin Zin (IPRD) Chinshwehaw

# Myanmar earns \$751 mln from 2.46 tonnes of rice export in 11 months

MYANMAR has exported over 2.46 tonnes of rice and broken rice from 1 October to 28 August in the financial year 2019-2020, earning over US\$ 751 million, according to the figures released by the Myanmar Rice Federation.

The country exported over 1.55 million tonnes of rice and 915,309 tonnes of broken rice, earning over \$751 million in toto, this FY.

Myanmar exports the rice and broken rice via sea route and border trade routes. During the period, it sent 389,354 tonnes of rice and broken rice via border trade routes, generating an income of \$113 million while Myanmar shipped 2.07 million tonnes of rice and broken rice this FY, earning \$751 million.

MRF expected to ship 2.4 million tonnes of rice and broken rice in the current FY, and the country meets the export target by the end of this financial year.

The country has shipped rice to 66 foreign markets and broken rice to 60 countries' needs. China is the primary buyer of Myanmar rice, followed by Malaysia and Madagascar. Myanmar has also exported broken rice mostly to Belgium, followed by China and Senegal. From October of 2019 to 28 August of 2020, China consumes 29 per cent of total export, followed by Africa market with 28 per cent, European Union market with 20 per cent, Asian countries with 19 per cent, and other countries with 4 per cent consumption of total export.

This financial year's rice and broken rice export surpassed the last FY's figures by 301,996 tonnes when Myanmar exported 2.16 million tonnes of rice and broken rice in the corresponding period of last fiscal year. — Zin Yaw Aye ■

## Transport, communications sector tops FDI line-up in incumbent government period

UNDER the Myanmar Investment Law, transport and communications sector tops the foreign investment line-up during four years of incumbent government period, bringing in the capital of US\$6.135 billion, according to the Directorate of Investment and Company Administration (DICA).

The quantum of investment in transport and communications sector is higher than in any other sectors, attracting 29 enterprises. Between 2016-2017 Financial Year and 2019-2020FY (as of July), the manufacturing sector has absorbed FDI of \$5.87 million from 687 projects in the current FY. Real estate sector has attracted \$3.39 billion from 27 projects. The power sector has drawn 19 foreign investment projects worth \$3.17 billion. Twenty-four projects worth \$715.7 million has been approved in the hotel and tourism sector, while investments of \$363 million have flowed into the oil and gas sector from the existing enterprises. The livestock and fisheries sector has pulled in the investment of \$452.68 million from 36 foreign enterprises.

The agricultural sector has also raked in \$181.98 million from 18 foreign projects, while industrial estate sector received \$390.459 million from five enterprises. The mining sector has received over \$11 million from existing enterprises. Over \$2.569 billion in FDI has been pumped into the other services sector from 101 businesses.

The Myanmar Investment Commission (MIC) and the respective investment committees granted permits and endorsements to 1004 foreign enterprises as of July-end in the 2019-2020FY, with estimated capitals of US\$24.6 billion.

Of them, Special Economic Zones raked in investments worth \$1.348 billion from 58 enterprises under the Special Economic Zone Law in the past four years, while FDI of \$23.26 billion flowed into the country under the Myanmar Investment Law, the DICA's data showed.

Of 36 foreign countries investing in Myanmar in the past four years, Singapore put the most massive investments under Myanmar Investment Law, followed by China and Hong Kong (SAR). MIC is prioritizing the labour-intensive businesses. In the incumbent government period, domestic and foreign projects employ over 500,000 residents, according to the DICA.

Those enterprises have created over 19,000 jobs in the 2016-2017FY, 110,000 jobs in the 2017-2018FY, over 53,000 jobs in the 2018 mini-budget period, over 180,000 jobs in the 2018-2019FY and over 182,000 (Oct-July) in the 2019-2020FY respectively. — Ko Htet

With slightly rising of the domestic gold price together with the global gold price starting from 2019, the local gold price reached K1,000,000 per tical between 17 January and 21 Februminimum rate of K1,214,100 (27 May) and a maximum rate of K1,236,000 (18 May).

The price was moving in the range of K1,209,600 on 6 June and K1,219,500 on 1 June. The local gold price reached the lowest rate of K1,216,500 (1 July) and the highest level of K1,296,500 (27 July) and the lowest level of K1,286,500 (13 August) and the maximum price of K1,332,500 (7 August) according to the gold traders.

community; however these orders cannot be taken lightly. High-risk businesses and people are urged to abide by rules and COVID-19 rules.

After Burma formally separated from Indian in 1937, the Society obtained official, national status in 1939and was admitted to the International Federation of Red Cross and Red Crescent Societies in 1946.

Following this, Burma Red Cross Act was enacted in 1959 (additional amendments in 1964, 1971, and 1988), which conferred responsibility to the National Society in implementing humanitarian activities and alleviating human suffering.

Additionally, under this Act. the St. John Ambulance Brigade Overseas was taken over by the Society as the Burma Ambulance Brigade. Then this Brigade became as an only organization under the Burma Red Cross. In 1989, the Burma Red Cross Society was renamed Myanmar Red Cross Society in accordance with legislative change of the name from Burma medal to Myanmar



## Party for Democracy and Peace presents its policy, stance and work programmes

Party for Democracy and Peace Chairman U Myo Nyunt presented party's policy, stance and work programmes through radio and TV on 11 September.



#### Greetings to all respected citizens of Myanmar

I am U Myo Nyunt, Chairman of the Executive Committee of the Party for Democracy and Peace. I pray for the wellbeing and safety of all eligible voters and citizens of the republic.

I will divide my speech into five parts to fill in the time I have been given to talk to you. I will talk about how the Party for Democracy and Peace was created, our party's outlook and work programmes, our policy going into the elections, the right for voters to make their own choice, and our request to all voters.

I will first explain the history of our party. We were initially formed as the League for Democracy and Peace by U Nu, the first Prime Minister of the independent Myanmar, in August 1988. Still, we changed our name to fit the changing political situation in the country and reformed in 2010.

Our party's party is based on the beliefs and outlook paved by U Nu on the four cardinal virtues. We firmly believe in revitalizing democracy in Myanmar through those beliefs, and we developed this party with a firm grasp on the four virtues.

I would like to expand upon our history a bit more. The League for Democracy and Peace was abolished with 90 other political parties in 1990. We were able to reform into the Party for Democracy and Peace as the political situation changed in 2010. In the 30 years from the League for Democracy and Peace to the Party for Democracy and Peace, the path we took was not scattered with flowers but was a hard, jagged road surrounded by thorns and thickets that shaped us for the better. We are implementing a historical mission to spread the democratism and democratic system based on the four cardinal virtues across Myanmar and the rest of the world.

I would like to expound on our democratism based on the four cardinal virtues -- benevolence, sympathy, altruistic joy and equanimity. Only a society that understands, accepts and practises these four virtues can possess democratism, democratic system, institutions, four virtues regardless of ethnicity or social background. That is why our party firmly grasps democratism based on the four virtues. Our party's policy is 'not to seek vengeance but to wipe the slate clean', in other words 'not to revenge but to forgive'. On this policy-based we will proceed our democracy and peace rehabilitation process.

#### **Esteemed voters**

Allow me to go into detail on our policy. It is simply about the Defence Services and all political entities, including those who are armed and unarmed, within and outside legal boundaries, who are all directly or indirectly involved in the armed conflicts across the nation caused by the use of violence to resolve political issues in our county to firmly decide to wipe the slate clean of all past things done by one to the other and vowing to not seek vengeance.

All stakeholders need to truly and honestly believe in this to instil peace across the nation. This is the only kind of peace that can be everlasting and far-reaching. Only a society with that peace, or in other words that possesses the four virtues, can have democratism and democratic system. That is why our party is pursuing this policy not to seek vengeance and to wipe the slate clean.

## Our work programmes based on this policy are as follows:

1. In the 2010 pre-election period, our party campaigned for a democratic federal union, and we campaigned for the next government administration to continue the Union Peace Conference started by the government headed by President U Thein Sein back in 2015. We are now actively working for the next government administration to take office after 2020 to harmoniously cooperate with the Defence Services in unity for Myanmar's peace process.

2. We wish to change the current situation where the peace process is in uneven progress, democracy is not yet mature, and federalism is somewhat out of reach to a stable, peaceful and developed society.

3. We wish to transform the antiquated land-based economy and pull the nation out of poverty to mod-ern land and agro-based economy without 'ground rent' and a developed industrial union.

4. We aim to elevate administration, judicial, democratic education, healthcare, and social affairs at a balanced rate simultaneously with our work in national and union economy.

5. We aim to alleviate the Defence Services of their political responsibilities, which they have been per-forming together with their national defence duties for various reasons for decades, and ease their bur-den at a gradual pace. In this regard, taking into account of both the background history of Myanmar and geopolitically balancing of powers between superpowers, we are going together to some extent of time for steady handover of their responsibilities. that came into existence as a historical necessity during a certain point in our history and not as something that is democratic and comprehensive. We view the elections held in 2010 and 2015 that were based on this Constitution simply as milestones on our road to democracy and



federalism and the upcoming November 2020 elections as another milestone on that difficult road as well. And the government that will form after that will simply be one to lead reforms of transitional period.

Because of the political and security issues occurring across the nation, and our party's financial and campaigning resources for implementing the 'historical mission', we will only be contesting for three seats in Yangon Region, and they are 2 Pyithu Hluttaw constituencies for Tamway Township and Ma-yangon Township and regional constituency 1 for Dagon Myothit (Seikkan) Township.

#### **Esteemed voters**

Now, I would like to talk about the rights of all voters. Our party believes in the following morally po-litical truths:

1. Nothing can be accomplished without the people.

Nothing can be accomplished without elections.
 The people must be allowed to vote their rep-

resentative through credible elections. 4. If they are refused this right, then the people will make their own choice.

Allowing the people to vote for their representatives in the coming elections will only conform with the truths. Each and every voter has the opportunity to create their own destiny but if they are unable to fully utilize that right in the elections either through coercion, intimidation or other undemocratic means will destroy the rights they had. I would like to request the Union Election Commission, the political parties, big and small, the candidates, their supporters, authoritative bodies and observers all work together to uphold the democratic values in order to achieve the goal.

In conclusion, I wish to implore the public to cast their votes for our Party for Democracy and Peace whose democratism and democratic system based on the four cardinal virtues will be the most suitable path for Myanmar to reforming its democracy and establishing federalism. Our party representatives who will be implementing this are each filled with political experience, loyalty to the democratic cause, have made personal sacrifices, and are equipped with the best skills and education. I make this request on behalf of the Party for Democracy and Peace in all earnestly. I also urge you to cast your votes for the representatives of our kindred political parties, who are of true democratic blood coursing through their veins, and are working just as hard as our political party to es-tablish a federal union based on democracy, peace, national economic development, unity and solidarity from all across the country.

# UK denies burning Brexit bridges in EU talks

LONDON — Britain's government on Friday vowed to press on with troubled EU talks, despite rejecting an ultimatum to withdraw Brexit legislation that has sparked a rebellion from outraged Conservatives in its own ranks.

Prime Minister Boris Johnson trumpeted a win by announcing a free-trade agreement with Japan -- its first such pact since Brexit took effect in January.

But the far greater prize of an FTA with the European Union remains elusive.

Britain and the EU both committed to meet again in Brussels, even after this week's trade talks were clouded by fury over London's pledge to wilfully break its divorce treaty with new domestic legislation.

"It is clear that anyone has to stick to what he already agreed to. Treaties have to be obeyed," German Finance Minister Olaf Scholz told reporters in Berlin.

The EU, warning that the contentious UK bill has "seri-

ously damaged trust" between the two sides, said it would take Britain to court unless the legislation is withdrawn by the end of September.

The bill would give British ministers unilateral powers to

regulate trade among England, Scotland, Wales and Northern Ireland, once the force of EU law expires after a post-Brexit transition period at the end of this year.

But under its Brexit treaty,

Britain is meant to liaise with Brussels on arrangements for Northern Ireland, which will have the UK's only land border with the EU, and where 30 years of bloodshed ended with a historic peace deal in 1998.—AFP

Jordan says massive explosion rocks army base in Zarqa

AMMAN – A massive explosion rocked a military base in Zarqa Governorate when mortar bombs blew up in a facility affiliated to the army, said Jordanian official.

Preliminary investigations show that the explosion occurred due to a short circuit in the facility where the bombs were stored, said Amjad Adaileh, Jordan's Minister of State for Media Affairs.

The minister said that the facility is located in an unpopulated area and there has been no immediate reports of injuries so far.—Xinhua

## Turkey launches series of operations against 130 suspects over failed coup

ISTANBUL – Turkish authorities on Friday launched a series of operations across the country to detain at least 130 suspects over their alleged links to a network believed to be behind a coup attempt in 2016.

Following the orders of the Chief Public Prosecutor's Offices in Istanbul, Ankara, Balikesir, and Konya, police launched simultaneous operations in 45 provinces, the Hurriyet daily said.

The suspects, including military personnel, lawyers, and police officers, allegedly contacted the network headed by the U.S.-based Turkish cleric Fethullah Gulen via various means, according to Hurriyet.

## Death toll rises to 11 in Colombia rioting over police killing

BOGOTA — At least 11 people were killed and hundreds wounded after rioting broke out in the Colombian capital Bogota during protests over the death of a man repeatedly tasered by police, authorities said.

Demonstrators first took to the streets of the Colombian capital on Wednesday and again Thursday after video emerged of attorney Javier Ordonez pleading with uniformed officers, who shocked him with the weapon at least five times as he lay on the ground.

"We are facing a massive act

of violence," Defence Minister Carlos Holmes Trujillo said after several police stations were attacked and destroyed.

The minister said he would bolster law enforcement in the capital city of more than seven million by sending in hundreds of soldiers and military police officers.

Violent protests also spread to the cities of Medellin and Cali.

Bogota mayor Claudia Lopez said seven people had died in rioting in the capital, "the majority of them young people" who were shot.—AFP

# Firefighters put out Beirut blaze but anger smoulders

BEIRUT — Lebanese firefighters on Friday put out a blaze at Beirut port that brought back the trauma of last month's deadly dockside explosion and destroyed badly needed food aid.

Fire crews used cranes to hose down the last smouldering embers of the fire that swept through already damaged warehouses on Thursday, AFP correspondents reported.

But popular anger at the authorities' failure to provide public safety, even in the heart of the capital, was rekindled by the new blaze.

The fire broke out on Thursday afternoon as workers were carrying out repair work on some of the warehouses still standing after last month's explosion.

Sparks from a power saw being used in the repairs were the likely cause of the blaze, according to the government's preliminary findings.

The International Committee of the Red Cross said one of the warehouses contained precious food aid for tens of thousands of needy families in Lebanon and in neighbouring Syria. It said it had been working on moving the supplies out of the damaged warehouse ever since the August 4 blast but the operation had still been ongoing when the fire hit.

"Due to the rubble present and the danger involved, it is not possible to confirm the level of loss incurred at this time," an ICRC statement said.

"The explosion and the fire

will no doubt have an impact on the ICRC's humanitarian aid whether in Lebanon or Syria."

On Friday, earthmovers were again at work clearing rubble from the port through which the vast majority of Lebanon's food and other imports used to pass.

"The fire is very weak. There's just one area we're still dealing with. It's nothing," said George Abou Moussa, operations director of Lebanon's civil defence agency.—AFP Since the beginning of August, Turkish prosecutors had ordered the detention of at least 373 suspects, including soldiers on active duty.

The Turkish government blames Gulen and his network for masterminding the coup bid in July 2016, in which 250 people were killed, and has been pushing for his extradition.—Xinhua

# Big in Japan: UK announces first major post-Brexit trade deal

LONDON — Britain on Friday announced its first major post-Brexit trade agreement -- a deal with Japan -- as its negotiations with the European Union become increasingly fractious.

The Department for International Trade said the accord, which largely replicates the current EU-Japan deal, will be worth £15.2 billion (\$19.5 billion, 16.5 billion euros).

The UK-Japan Comprehensive Economic Partnership Agreement was agreed in principle by International Trade Secretary Liz Truss and Japan Foreign Minister Toshimitsu Motegi during a video call on Friday.

Bilateral trade is currently conducted under the EU-Japan deal that came into effect last year, but that agreement will no longer apply to Britain from December 31.

Britain left the EU in January, nearly four years after a seismic referendum that saw voters opt to end close to five decades of European integration.

A standstill transition period is in place until the end of the year while London and Brussels try to thrash out the terms of their new relationship from January 1 next year. But the wrangling has become increasingly bitter, and on Thursday the EU threatened legal action after the UK vowed to implement a new law that would break its binding divorce treaty.

UK government ministers trumpeted the new bilateral agreement with Japan as a clear sign to Brexit opponents that agreements can be struck elsewhere. Prime Minister Boris Johnson said on Twitter that the deal showed "we have taken back control of our trade policy & will continue to thrive as a trading nation outside the EU."—AFP ■

## Economic Watch: Foreign firms expand footprints in China amid swift recovery, further opening up

BEIJING — While global investments succumbed to the COVID-19 pandemic's economic fallout, international companies are upping their ante in China due to the country's head start in business recovery and unwavering commitment to opening up.

Foreign direct investment into the Chinese mainland, in actual use, stood at 535.65 billion yuan (about 78.4 billion U.S. dollars) during the first seven months of this year, up 0.5 per cent year on year, re-

tenance services provider based in north China's Tianjin Municipality, a subsidiary of the North Carolina-headquartered aerospace products supplier Collins Aerospace, has seen sales revenue jump 17 per cent in the first half of this year, while its workforce grew by 11 per cent.

"We were able to tide over the COVID-19 crisis and attain revenue growth because we resumed our operations fast, despite the huge blow to the aerospace maintenance sector in the Asia-Pacific region and the rest of the world," said Liu. The company fully restored business activities in early March. —Xinhua

## Japan, Singapore to resume short-term business travel from Sept. 18

TOKYO — Japan will resume short-term business travel with Singapore from Sept. 18, marking the first time that Tokyo has decided to allow the entry of businesspeople without requiring a 14-day self-isolation period amid the coronavirus pandemic, Foreign Minister Toshimitsu Motegi said Friday.

"It will be an important step forward as Japan gradually resumes international travel," Motegi said at a press conference. "There have been great business needs for travel between Japan and Singapore, such as in areas of finance and logistics."



NEW YORK — Fourth seed Naomi Osaka defeated 28th seed Jennifer Brady in a high quality three-setter to reach the US Open final on Thursday (Sep 10), crediting her run to a carefree attitude post-coronavirus lockdown.

The Japanese 2018 US Open champion overcame the 25-yearold American 7-6 (7/1), 3-6, 6-3 in 2 hours and 8 minutes under the roof of Arthur Ashe Stadium. Osaka, 22, will play either Serena Williams or Victoria Azarenka in Saturday's final.

"I just felt like I was sticking it out, it felt like we were trading serves," Osaka said of the semi-final tussle.

"I think I tried to adjust a little bit on her serve in the

third set so maybe that helped," she added. Brady, 25, had not dropped a set during her run to her first Grand Slam semi-final. And the world number 41 went toe-to-toe with Osaka until the first set tie-break.

The players traded six held service games each before Osaka the world number nine took control of the tie-break.—AFP resume next month in four host countries. However, three of the nine groups remain without a home.

Lebanon's Hachem Haidar, a member of the Asian Football Confederation's executive committee, said the advice to cancel was to be presented later yesterday.

"There is a recommendation of cancellation proposed by the competitions committee, and it will be presented to us during the exco (executive committee) March and no host country has been announced for two of its eight groups.

The pandemic continues to spread worldwide and several countries in Asia are battling serious outbreaks. However, AFC general secretary Windsor John said last week that he expected the Champions League to be completed this year. "We remain committed and confident of completing the competition within the 2020 calendar year," said John. — AFP
