# Pyithu Hluttaw approves Myanmar Insolvency Bill

MYANMAR INSOLVENCY BILL was approved during the fourth-day meeting of the 14th regular session of the Second Pyithu Hluttaw held in Nay Pyi Taw yesterday. Also at the meeting, asterisk-marked questions were asked and answered and a report on the Pyithu Hluttaw Judicial and Legal Affairs Committee was read.

Asterisk marked questions and answers

Seven questions were raised by Hluttaw representatives and answered by Deputy Minister for Transport and Communications U Thar Oo and Deputy Minister for Construction U Kyaw Lin.

MP Dr U San Shwe Win of Yekyi Constituency asked which ministries were cooperating on the e-Government Master Plan (2016-2020) to which U Thar Oo replied that the process requires continued updating and development by nature, and therefore requirements may change to accommodate the situation. He said the process is guided by the e-Government Steering Committee.

The Deputy Minister also answered to a question raised by MP U Thein Tan of Hlegu constituency on the legality of a closed Multi-purpose Community Telecentre operated by the Directorate of Communication as the building is losing computers and accessories and the flags of a political party has been set up on it.

MP U Myint Oo of Thanatpin Constituency asked if there were plans to reconstruct the steel-reinforced wooden bridge on the Thanatpin-KweTe road to a concrete one after it had been damaged by natural disasters

Deputy Minister U Kyaw Lin replied that repairs to the bridge will be included in the budget of the 2019-2020 FY but upgrading it will be considered in the Bago Region cabinet's budget proposal for 2020-2021 FY.

Questions by Dr Lin Lin

Kyaw of Myittha Constituency, U Phone Myint Aung of DaikU Constituency, U Tun Wai of Phaungpyin Constituency and U Tin Aye of Metmung constituency covering plans to repair a damaged bridge, upgrading roads, built a bridge and continuing the laying of a village road in respective constituencies were answered by Deputy Minister for Construction U Kyaw Lin.

Hluttaw approves Myanmar Insolvency Bill

Next, Bill Committee secretary U Kyaw Soe Lin tabled a motion to approve the Myanmar Insolvency Bill with 737 points amended by the committee. Pyithu Hluttaw Deputy Speaker obtained the consensus of the Hluttaw and approved it.

Pyithu Hluttaw Deputy Speaker then obtained the Hluttaw's opinion on approving the entire bill as amended by clauses and sub-clauses. As there was no objection, an announcement was made of the

THE second Amyotha Hluttaw's 14<sup>th</sup> regular session held its fourth-day meeting at the Amyotha Hluttaw meeting hall yesterday morning.

Hluttaw approves reformation of Amyotha Hluttaw Education Promotion Committee

In the first agenda of the meeting, Amyotha Hluttaw Deputy Speaker informed the replacement of Amyotha Hluttaw Education Promotion Committee member Col Htein Lin with Brig-Gen Aung Zaw Oo and obtained the Hluttaw approval of the reformation of the committee.

#### **Electricity matters**

MP U Aye Min Han of Mon State constituency 1 raised a question on whether there were plans to connect Kaw Tun, Kaw Pauk and Kaw Sein villages in Mawlamyine Township to the national electric grid.

Deputy Minister for Electricity and Energy U Khin Maung Win replied that the funding for the process will be

allocated in the budget proposal of either the Mon State Government fund or Union fund for 2023-2024 FY.

MP U Tun Tun Oo of Mandalay Region Constituency 2 rasied a question on what arrangements have been made to prevent power cuts during the hot summer season in 2020.

U Khin Maung Win replied that they are implementing

seven projects approved by the Union Government, in their meeting No 12/2019, to provide a combined 1,165MW across the whole nation.

The Deputy Minister said they are also implementing 500KV transmission lione and sub-power station projects, a System Improvement Plan, and System Development Plan to ensure sufficient energy is generated to meet the growing energy demand in the nation.

U Khin Maung Win also noted that the frequency of system breakdowns has decreased gradually from 17 times in 2016 to thrice in 2017, twice in 2018 and only once so far in 2019. He said they will pay special attention to further reduce any power cuts in 2020.

**Education matters** 

MP Naw Hla Hla Soe of Yangon Region Constituency 10 raised a question on whetherlegal land grants for basic education schools in Insein and Mingaladon townships will be issued quickly.

Deputy Minister for Education U Win Maw Tun replied that the holders of the land, who may be other government ministries or the Tatmadaw, must first relinquish the land to the State in order for the Ministry of Education to continue any processes for applying a grant.

Questions raised by U Kyaw Than of Rakhine State Constituency 10 on upgrading a school and construct a new school building, and U Mahn Law Moung of Chin State constituency 8 on plan to appoint more ethnic national language teachers were also answered by Deputy Minister for Education U Win Maw Tun.

Bill Committee report on Industrial Zone Bill

Following the question and answer session, bill committee report on Industrial Zone Bill approved and sent with an amendment by Pyithu Hluttaw was read and explained by committee member Brig-Gen Tint Lwin.

Afterwards, Amyotha Hluttaw Deputy Speaker announced for Hluttaw representatives who want to submit amendment motion on the bill to register their names.

## President U Win Myint attends MRCS conference, anniversary event

Looking back at the history of MRCS, it can be seen that it was the country's oldest and longest serving compassionate humanitarian group that strives and cares for development of vulnerable persons who face dangers. Red Cross works were conducted in Myanmar since 1920 as a branch of Indian Red Cross Society and became an independent society in 1937. ICRC recognition was obtained in 1939 and in 1946 it also became a member of IFRC.

In 1952, Maha Thiri Thudhamma Daw Khin Kyi, wife of independence architect Bogyoke Aung San and mother of the State Counsellor took up the responsibility of Chief Nurse with much compassion and sympathy. During that year in order to rapidly implement the works of the Society and to be in accord with basic principle of democracy, members were elected to administer the Society.

The Burma Red Cross Act enacted in 1959 established the Society as a permanent humanitarian entity. The Act was amended in 1964, 1971 and 1988. As per the act, St. John Ambulance Association was also incorporated as part of the Burma Red Cross Society. In 1989, Burma Red Cross Society was renamed Myanmar Red Cross Society was renamed Myanmar Red Cross Society and MRCS Law was amended in August 2015 to be in accord with the times.

2020 aim of MRCS is to become a fully capable national Red Cross society that provides social compassionate assistance to local and international vulnerable

persons

The State has given due recognition and support to MRCS's social compassionate assistance works while feeling encouraged to find MRCS conducting its work under the seven fundamental principles of humanity, impartiality, neutrality, independence, voluntary service, universality and unity. It was recognized with pleasure that the election for the next three year term was held in a transparent manner showing that it was heading towards a democratic path.

There were no organizations or entities that were fully and completely developed. Changes and reforms need to be made accordingly while courage to change was also required. There must be the capability to make changes and also the ability to

withstand and overcome difficulties. Knowledge and foresight are required to differentiate between what to change and what not to change. Changes were to be made where changes are due and all are urged to strive more toward leaving a good record in the history of Red Cross, to be on par internationally and to conduct more social compassionate assistance works.

By conducting its works, MRCS is a reserve force for the State in the humanitarian field. It will also support by cooperating in implementing national projects and policies established by the State for its development. As the State had also assigned MRCS by law to provide assistance without discrimination this also needed to be done accordingly.

Help and assistance provided by Red Cross volunteers and Red Cross personnel for 80 years will be remembered forever by all. The State recognizes and honor the Society's outstanding works during these 80 years.

It is believed that good leaders will emerge at all levels of the Society to conduct social compassionate assistance works for the next term. May the Society conduct all its work in unity under the leadership of those leaders. May they work toward brightening the image and honor of the Society. May cooperation with international partner national Red Cross Societies become stronger.

May the 2020 MRCS Strategic aims be achieved and establish a peaceful and cultured society, said the President.

Next, the President presented certificates of appreciation to three MRCS members who donated blood for 120 times and more.

Afterwards the President, Union Ministers, Union Attorney-General, Union Auditor-General, Nay Pyi Taw Council Chairman, Deputy Minister and MRCS President took a commemorative group photo with attendees.

After the event the President cordially greeted the attendees and observed the MRCS exhibition, displaying the works of MRCS. The second part of the event was then held where Union Minister for Health and Sports Dr Myint Htwe presented certificates of appreciation to six MRCS members who donated blood for 100 times and more. #### Speech of Senior General Min Aung Hlaing

Commander-in-Chief of Defence Services Senior General Min Aung Hlaing also made a speech, saying that:

First of all, I would like to pay obeisance to Sayadaws and members of Sangha who are present on this occasion. And I wish physical and mental well-being and auspiciousness for spiritual leaders of different faiths, the State Counselor, vice-presidents, parliamentary speakers, Union ministers, deputy ministers, heads of departments, foreign diplomats, representatives of UN agencies, officials of (RfP-M) and invited guests.

I am delighted and honored to make my first speech at the third advisory forum of the RfP-M on national reconciliation and peace.

I am aware that the topics that will be discussed at the forum can well reflect and facilitate promotion of eternal principles of justice, liberty and equality as well as stability, peace and development of the country.

It is clearly stated in the Constitution that eternal principles must be enhanced inside the country and regarding international relations, "The Union practices independent, active and non-aligned foreign policy aimed at world peace and friendly relations with nations and upholds the principles of peaceful co-existence."

#### To achieve stability, eternal principles of justice, liberty and equality must be flourishing

Food, cloth and accommodation as well as the access to secure livelihoods are basic needs of the world's population. The most important thing for those needs is peace in other words stability of the country. To achieve stability, eternal principles of justice, liberty and equality must be flourishing. The common advices of different religions is to practise loving-kindness, do good deeds and avoid bad deeds, seek wisdom to be able to differentiate between good and bad, and have an impeccable moral character.

With regard to eternal principle of Justice, the Constitution states "the Union shall guarantee any person to enjoy equal rights before the law and shall equally

provide legal protection." With regard to Equality, it states "the Union shall not discriminate any citizen of the Republic of the Union of Myanmar based on race, birth, religion, official position, status, culture, sex and wealth." With regard to liberty, it provides individuals with freedom and rights in line with law. It is important that we respect, abide by and implement according to the law.

Despite the fact that every country around the world has citizens of different religions, all of them pay heed to the religion which is practised by the majority in the country. For example, 73 percent of the national population practise Christianity in the United States of America; Hindu followers account for 80 percent of national population in India while 89.5 percent of the national population belong to Islam in Bangladesh. It should be aware that those countries.

Cultural evidence suggests that religious beliefs in Myanmar date back to Pyu Period, the most ancient period of the country. Pagodas in Bagan are testimony to the fact that Theravada Buddhism has been practised by the majority since Pagan Period, the first Myanmar Empire in AD 11. And there are also comprehensive historical records that the majority of Myanmar citizens have wholeheartedly embraced Buddhism in successive periods. Only after Myanmar fell under colonial rule, followers of Christ and other religions have increased.

Till today, around 78 percent of Myanmar's population is Theravada Buddhists. Therefore, the Union recognizes special position of Buddhism as the faith professed by the great majority of the citizens of the Union. The Union also recognizes Christianity, Islam, Hinduism and Animism as the religions existing in the Union

Burmese language is the official language of the Union; and only by providing education uniformly to all the ethnic people, can Myanmar's education develop as expected. We have to ensure every citizen has completed at least lower secondary level and acquire knowledge and skills, as we have targeted.

Regardless of religions, all of us are "Myanmar", being the citizens of Myanmar, and must therefore adopt Myanmar Spirit and pledge loyalty to the country. I understand there may be rituals based on culture, customs and religious practies, but instigation on the pretext of religion is unacceptable, and such instigation should not be supported.

Today, we have been able to sign the Nationwide Ceasefire Agreement (NCA) in order to take practical steps for internal peace and unity, which is the fundamental requirement of the country. As we are undergoing democratization today according to the wishes of people, pressing demands by wielding arms is unacceptable. We should put aside arms and engage in dialogue to achieve peace. If there is genuine desire for peace, there is no reason that cannot be achieved.

People hope that NCA signatories will continue to implement the agreement with genuine loving-kindness and goodwill in the interests of the country and citizens. And I would like to invite the non-signatories to give up unlawful and insurgent acts, which

are the opposite of peace, and walk on the right track of peace, in consideration of the people.

In conclusion, I hope the third advisory forum of the Religions for Peace-Myanmar on national reconciliation and peace in Myanmar will deliver encouraging results. I hope all the Myanmar citizens can address poor wisdom, loose morals and egoism, which are the root-cause of all conflicts. I hope they can work together in unity without discrimination on the grounds of race and religion, with the belief that "The strength of a country lies within", to achieve peace and promote eternal principles, and work to the best of their ability to achieve genuine, permanent peace as soon as possible.

With the belief that all the religions emphasized loving-kindness, he also quoted a verse of Buddha teaching 'Hatred is never appeased by hatred in the world. By non-hatred alone is hatred appeased. This is a law eternal for those who prefer living away from the hatred to lead a peaceful life.'

He finally expressed his quotation of 'Peace not only our job, but also our life'.

Then, RfP Chairman U Myint Swe and Honorary President of International RfP, Bishop Gunnar Stalsett delivered speeches on organizing the forum, and the joint chairman of RfP Oxford Sayadaw Prof. Dr. BhaddantaDhammasami explained a statement of agreement on harmony.

Then, PNLO's Patron Khun Okka also said while all the country has suffered from the impacts of instability, the consequences are the most serious in ethnic areas. He recounted his bitter experience as a refugee of internal armed conflicts when he was three years old in Thathon district of Mon state.

He also suggested to solve the armed conflicts through dialogues in considering about the sufferings of innocent civilians, and to develop humanity by avoiding extremism which is the root cause of hostility.

He also remarked the practices of extreme nationalism, militarism and hatred could result in fascism. Although it has been assumed that the fascism has terminated since the end of second world war, certain forms of extremisms have appeared

# World Diabetes Day 2019 observed in capital

THE WORLD Diabetes Day 2019 was commemorated at the Ministry of Health and Sports in Nay Pyi Taw yesterday.

Union Minister Dr Myint Htwe spoke at the opening ceremony. He said diabetes is the main cause of damage to the kidneys and someone who has it is 15 to 40 times likelier to require a leg amputation due to the negative consequences of the noncommunicable disease.

In addition, people with diabetes are 25 times more likely to lose their eyesight, said the Union Minister. He said hypertension usually accompanies people with diabetes and the best way to prevent both noncommunicable diseases from occurring is to regularly engage in a physical activity of one's

choice

The Union Minister said there are 1,316 rural health centres in 232 townships across the nation that opened free hypertension and diabetes clinics from October 2018 to July 2019. He said 1.1 million people came to these clinics and 5 per cent of them had diabetes while 15 per cent had hypertension.

The Union Minister said just as it is mentioned in the motto of this year's World Diabetes Day, "Diabetes: Protect Your Family", the role of the family is crucial. They must be aware of the do's and don'ts for a person with diabetes in their life.

Next, Prof Dr Ko Ko of the Diabetes and Hormone Treatment Department, University of

# UEC warns against joint statement of 20 political parties

THE Union Election Commission has warned against a joint statement of 20 political parties, dated on 2 November.

The joint statement included false and groundless information about the commission, tarnishing its dignity and morals and creating confusion among some political parties and the voters for 2020 General Election, the UEC said yesterday.

The commission also quoted the sub paragraph (c) and (d) under the Section 6 of the Political Parties Registration Law, to respect and obey the Constitution of the Republic of the Union of Myanmar and to abstain from writing, delivering speech or organizing and instigating that can cause conflict or that can affect dignity and morals relating to nationality, religion, individual or public.

The UEC also warned that the commission's 33/2019 meeting on 6 November has decided to inform responsible persons of these 20 political parties about possible legal actions if they breached the Political Parties Registration Law in the future.

If any political party failed to abide by this law, it shall not be entitled to subsist as a political party. —MNA

T is impossible to not notice the powerful natural disasters rattling many places in different parts of the world in these recent years. Just last month in September, a particularly strong earthquake destroyed numerous buildings in Albania and caused thirty to forty casualties.

The dengue fever situation in Sri Lanka and Bangladesh was ongoing into last August, affecting about sixty-thousand

people in Sri Lanka while some sources report it has affected at least a hundred thousand, causing 70 deaths out of every 100 persons. It has also affected about 2,500 people in Bangladesh and the numbers continue to rise.

Unusually high temperatures during the dry season caused wildfires in the Amazon rainforest in October and have left about two million forest creatures dead or home-

And just a few days ago, a 4.1 magnitude earthquake about 30 miles to the north of Yangon is the talk of the town these days, hitting a bit too close for Yangonites' comfort. And then there was the recent cyclone in Tokyo, Japan, that flooded large areas and left about 80 people either dead or missing

The Australian government has announced a state of emergency con-

cerning the bushfires that have been raging across its eastern lands and the strong hurricane in America and volcanic eruption in Indonesia are other examples of direct effects of natural disasters.

These are just prominent disasters that have made the news but there are many more out there occurring around the same time that are just as deadly, if not more.

Natural disasters will strike without warning no matter how prepared you are. But that doesn't mean we shouldn't implement effective countermeasures in place and leave everything to chance. And it doesn't just stop there. The aftereffects and lingering consequences of natural disasters may persist for months or years.

Developed nations have emergency-response teams in place and their people are properly educated and aware of what to do when natural disasters strike. This has made effective mitigation of casualties for their people.

Likewise, Myanmar needs to be better prepared for natural disasters. There needs to be more awareness-raising campaigns and plans in place to respond immediately to natural disasters and also to take care of the consequences that follow.

# My years with UEHRD

UST over a week ago. the Union Enterprise for Humanitarian Assistance, Resettlement and Development in Rakhine (UEHRD) commemorated the second anniversary of their founding in Nay Pyi Taw.

The State Counsellor delivered a heartfelt speech at the event, which was wholeheartedly attended by relevant officials, ambassadors, civil society organizations and members of the UEHRD as well. Rakhine youths provided entertainment with traditional dances and performances and a video on the progression of education in the state was played.

#### The journey from two years ago

While I was attending the anniversary of the UEHRD, my mind floated back to two years ago when it was first established. I was thinking of the thoughts and conceptions at that time and also comparing it with the one year anniversary from the previous year. The UEHRD was established by State Counsellor Daw Aung San Suu Kyi and she leads it as well.

UEHRD was founded to respond to the various conflicts spawned by the attacks from ARSA on 25 August, 2017. The State was able to lead the private sector to participate. Businesses from Myanmar donated to the UEHRD to fund its efforts. They took oaths. The State Counsellor took the position of Chairperson and formed it with the two remaining peo-

A meeting was held at UM-FCCI to gather the participation of businesspersons and different task forces were formed and delegated specific tasks so that they may be performed more effectively.

We faced two emergency issues at that time. The first was we needed to construct reception centre and transit centres for people who fled across the border. Secondly, we needed to reap the abandoned rice fields in time, as they were already

structure Task Force quickly to construct the Taung Pyo Let We Reception Center and Hla Pho Kaung Transit Center. Myanmar's construction businesses participated enthusiastically and we swiftly performed land clearing tasks and construction

We were short on staff and materials but we persevered to complete everything on time We gathered the cooperation of local businesses as well. Given the gravity of the situation, we could not prioritize all protocol or schedules and handled the situation as an emergency.

U Chit Khaing led the efforts to reap the crops in time. At the same time, Asia World Chairman U Tun Myint Naing took responsibility for the large-scale repairs on the Sittway-Maungtaw Road. We were aided in our efforts by 30 construction companies in Sittway.

#### Not everything was a success

The UEHRD has changed gradually over the course of two years. Once consisting of only four members, it has grown to include eleven more with representatives from various ministries too. A new task force for international relations was also set up and is led by Daw Pyone Kathi Naing and the Outreach Working Group Which is why we formed (OWG) was formed for various supporting tasks. We tried to

operate UEHRD's tasks effi

As I listened to the State Counsellor's speech on the UEHRD's 2nd anniversary, I contemplated on the journey we had taken thus far. While we had our fair share of accomplishments, we also couldn't find success in certain areas. There were many lessons learnt.

We need to extend our gratitude to those who deserve it. Many businesses graciously accepted Daw Aung San Suu Kyi's request for assistance and many of members paid out of their own pockets while performing their duties. I can guarantee there were no backand-forth deals made like in the days of the past. Everyone volunteered their time and money.

Of the ten task forces, some performed prominent tasks but others were less obvious. There is no reason to assert blame for not performing well. We had to give our all and accept if there were no successes. We need to rethink what preparations to make to perform it well.

When we talk about UEHRD, we need to be able to differentiate between the committee and task force. The committee acts as the administration mechanism and sets policies and coordinates negotiations as necessary. The task forces, on the other hand, are working for the benefit of the nation by their own volition

and compassion. That's why their efforts can't be viewed as part of the administrative

When reviewing the twoyear journey of the UEHRD, we can separate them into two parts -UE and HRD. UE stands for Union Enterprise and there is meaning to each word. Union indicates the level of work that we are carrying out.

Enterprise can mean business, but here it denotes innovation and leadership. In a way, it indicates the Public-Private Partnership (PPP) between the government and the people. Now, the UE has three tasks, namely Humanitarian, Resettlement, and Development tasks. All three tasks are interrelated.

## A group to fill in the

We have to acknowledge that relevant government ministries are taking responsibility for each of the three duties mentioned above in Rakhine State, while the local cabinet is doing so as well. That is why the UEHRD can be thought of as filling in the work where

We are not taking on all the duties by ourselves, but rather we are providing our expertise

in the areas they are most beneficial. Members of the UEHRD were able to explain of our processes and progress on visits to foreign nations during the two-year journey.

The various conflicts in Rakhine State can trace their roots back to years of issues present in the area. There are a lot of complications and difficulties, and a general loss of trust in the community.

When the activities of the AA began in the early part of 2019, we received greater challenges in our efforts. The UEHRD was affected as well. A fundamental aspect of the conflicts in Rakhine is economical in nature. If we can implement sufficient development, then we can deal with the conflicts in a way.

That is why we endeavoured to attract foreign investment into Rakhine State during our two-year journey. During the expo held in Ngapali Beach, we successfully signed an MoU with Thai-based IBERD and organized training courses for prawn-breeding.

We are currently implementing an electrification project and organizing to construct a warehouse freezer. We have signed an MoU with a Korean company to construct a textile

A little while ago, I met with Rakhine businesses in Sittway and discussed transforming Maungtaw into a border trade centre. While the conflicts are indeed ongoing, trading had never stopped in the area. Buying and selling continue to take place. We can see that there is no adverse effect on bilateral trade and we need to give all our support to this matter.

While attending the second year anniversary, I also think ahead to what I can report about or uncover in another year's time. We need to carry our obligation to the three tasks even further than we currently have. We need to cut back on unnecessary administrative functions and encourage inno-

# Tourist arrivals in Mingun via Mayanchan jetty up 10%

THE number of tourist arrivals in Mingun at the opposite bank of Mayanchan jetty in Mandalay Region increased by 10 per cent in the first week of November in comparision with the previous year, said U Thet Tun, chairman of vessel operators association.

Locals as well as foreigners paid the same rate for transportation, fixed at K35,000 per vessel for 5 persons and K64,000 for 6-10 persons. The vessels can carry a maximum of 20 passengers.

"During the high season, Mingun Town hosts a flock of visitors and 50 or 60 ships transport tourists every day. Most of the tourists are Chinese. With the tourist arrivals increasing in Mingun Town, 50 to 70 ships have been transporting visitors each day, starting 7 November," he added.

Mingun is normally crowd-

ed with the visitors mostly in November, December, and January. However, the number of Chinese travelers is increasing these days, and one tourist vessel leaves Mayanchan jetty at 9 am and returned from Mingun jetty at 1 pm.

"We are running two rounds daily, charging K5,000 per foreigner, and we earn well in these four months every year. Over the past two days, 200 Chinese visitors have come to Mingun by ship. Normally, they don't take a ship to visit

Mingun Town," said a vessel

#### Thaphanseik Dam water insufficient for summer paddy, officials plan for alternative crops

WITH water levels in the Thaphanseik Dam in Sagaing Region insufficient for irrigating summer paddy fields, officials from the Regional Agriculture Department are planning to cultivate other crops which do not require much water, said U Win Hlaing Oo, head of the Sagaing Region Agriculture Department.

The water level in the dam reached over 2.5 million acre-feet in October last year, but the water level in the dam has reduced to 646,000 acre-feet in the same month this year, according to data on 21 October.

"Due to the climate changes in Sagaing Region, the dam has recorded low water levels due to inadequate rainfall around the catchment area. The catchment area is 3,460 square miles long and rainwater can enter the dam only if rain falls around the area. The dam had recorded water level of over 3.5 million acre-feet last year," said U Soe Naing.

"At present, we have saved sufficient water to irrigate 360,000 acres of rain paddy fields. The dam can supply 1.1 million acre-feet of water this year, although it has been providing 2.1 million acre-feet of irrigation water to paddy fields every year," he added.

Officials from related departments, Hluttaw representatives, and administrators have conducted awareness talks to reduce the use of irrigation water. The cultivation of monsoon paddy will be completed by the end of November, according to

one farmer. A water utilization project will be conducted for Shwebo residents after the monsoon paddy period. The rest of the irrigation water will be saved for cultivation. "Although there is 640,000 acre-feet of water in the dam, 140,000 acre-feet is dead water. At the end of June, 260,000 acre-feet of water will remain in the dam after factoring in evaporation and the dead water level," said U Soe Naing. - Myo Win Tun (Monywa)

## Private nursing school to start on 18 Nov in North Dagon Township

THE first private nursing school will be opened in North Dagon, Yangon Region, on 18 November in order to fulfill the country's requirements for nurses, according to the preopening ceremony for the training school, which was held on the morning of 13 November at the New Life Foundation. The training school will be opened with the permission of the Ministry of Health and Sports and the Myanmar Nurse and Midwife Council.

"Nowadays, there is a high demand for qualified nurses in the country and across the world due to a shortage of nurses. We feel delighted in taking the first step towards fulfilling the country's requirement by offering nurse training courses at private nurse schools with the aid of related ministries," said

At the event, trainees from across the country enrolled for the nursing training course. The school will admit only 30 students this year. Those who have passed their matriculation exam can enroll for the three-year training course. Trainees will be offered a diploma and trained under the same curricula as the University of Nursing, including in patient care, telemedicine, English, computer, nursing administration and management, advanced machine learning for nurses,

emergency nursing, mental health, critical care, and fundamental nursing subjects.

Globally, 28 nurses are needed per 10,000 population, but there are only 9 nurses for every 10,000 people in Myanmar. According to data, the government nursing universities are producing about 3,000 nurses per year, while over 10,000 nurses are required. The requirement for nurses has prompted the private sector to open training schools.

Four private nurse training schools, including Shwe Zanaka Private Nurse Training School, are planned to be opened in Myanmar with the permission of the Myanmar Nurse and Midwife Council and the Ministry of Health and Sports.-Myint Maung Soe (Translated by Kyaw Zin Lin)

## UMFCCI, JCCI co-organize Myanmar-Japan business cooperation meeting

THE Union of Myanmar Federation of Chambers of Commerce and Industry (UMFCCI) and the Japan Chamber of Commerce and Industry (JCCI) organized the 15th joint meeting of Myanmar-Japan Business Cooperation Committees on 14 November at the UMFCCI office.

About 20 Japanese businesspersons in heavy industry, aviation, technology, legal consultation, education and services, and energy attended the meeting.

During the meeting, experts from Myanmar discussed cooperating in the country's tourism and human resource development businesses.

"The UMFCCI and JCCI have been collaborating for over 20 years now. The meetings were alternatively held in both countries, and the 15<sup>th</sup> joint meeting was convened in Myanmar this year. The meet-

ing outcomes between the two countries have shown improvement in investment," said U Zaw Min Win, President of the UMFCCI.

"Myanmar and Japan have close relations and the two countries prioritize mutual trust," said U Zaw Min Win.

"At present, Myanmar government has been focusing on economic growth and I hope this joint meeting will help deal with the possible investment obstacles and support investment promotion," said Mr Ichiro Maruyama, Ambassador Extraordinary and Plenipotentiary of Japan to the Republic of the Union of Myanmar.

"As per the messages sent by Prime Minister Shinzo Abe, Myanmar government is focusing on economic reform. I wish the private sectors from the two countries discuss foreign investment difficulties in the meeting. So, we can report the meeting outcomes to the governments.

They will continue to work on this after government-to-government discussions," he said.

At present, Japan is ranked 10<sup>th</sup> among 50 countries with a large share of investment in Myanmar. Between 1988 and

30 September this year, 117 Japan-listed enterprises have been permitted to bring investments of US\$1.2 billion into the country, according to statistics released by the Directorate of Investment and Company Ad-

ministration.

Foreign investments of over \$670 million have flowed into the Special Economic Zones (SEZs) from 39 Japan businesses, under the Special Economic Zone Law. (Translated by Ei Myat Mon)

THE Shan State Investment Forum will be held on 26 November at the Royal Taunggyi Hotel, Taunggyi, Shan State to promote investments in the agriculture sector in the state.

The forum is being organized by the Myanmar Investment Commission (MIC), Shan State Investment Committee (SSIC), and supported by Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ).

Senior officials from concerned ministries and representatives from the private sector will join the forum as speakers and panelists and cover investment opportunities in the agricultural sector, according to the Directorate of Investment and Company Administration (DICA).

Additionally, a site visit to agriculture farms and food processing industries will be organized on 27 November in Southern Shan State.

Shan State is strategically located in terms of business and investment as it shares borders with Laos, Thailand, and China. The state is the largest in Myanmar, accounting for 23 per cent of the land area of the country.

Shan State has good potential for investment in agriculture and food processing industries.

Also, with its highland climate, Shan State is the main producer of some fruits, vegetables, and crops such as rice, corn, maize, wheat, garlic, potato, ginger, sweet potato, coffee, herbs, and spices. The state also possesses a young labour force, along with rich natural resources and fertile agricultural land.

The MIC has been organizing investment fairs to attract local and international investors and to ensure the states and regions develop more evenly.

The DICA has been apprising local and international investors of the latest developments such as the recent enactment of the new Myanmar Investment Law and new investment opportunities.

Under the new Myanmar Investment Law, those investing in undeveloped regions will be given tax exemptions as an incentive. The new law has also authorized Investment Committees of regions and states to approve local and foreign projects where the initial investment does not exceed K6 billion, or US\$5 million.—GNLM

# Domestic oil prices rise on positive global cues

DOMESTIC oil prices have been on the rise since August-end tracking the surge in the global market, according to traders.

Oil prices have jumped by K90-100 per liter compared with October's prices in the local market, said traders.

Global oil prices have rebounded on a crude oil inventory draw by the American Petroleum Institute (API), according to the global market. On 14 November, brent crude oil was priced at US\$62.7 per barrel, while WTI crude stood at around \$57.5 a barrel in the global oil markets.

Meanwhile, Octane 92 was pegged at K880, Octane 95 at K980, diesel at K960, and premium diesel at K970 per liter, according to the domestic oil retail market.

On 10 October, 2018, due to an increase in global crude oil prices and the weakening of the Kyat against the US dollar, oil prices had touched a high of K1,065 per liter for Octane 92, K1,115 for Octane 95, K1,085 for diesel, and K1,105 for premium

On 1 January, domestic fuel oil prices touched a low of K695 for Octane 92, K760 for Octane 95, K870 for diesel, and K875 for premium diesel. In April, the prices crossed K1,000 per liter, and then dipped below K1,000 in June, when oil prices registered an extended drop in the global market. The prices dipped by three to five per cent in July and early August. Thereafter, they have been on the uptick, according to the local oil market.

Ninety per cent of fuel oil in Myanmar is imported, while the remaining 10 per cent is produced locally.

Myanmar imported more than 4.9 million tons of fuel oil worth more than \$2.9 billion in the 2018-2019 fiscal year, according to the Ministry of Commerce. Myanmar imports fuel oil primarily from Singapore, with monthly volumes touching 200,000 tons for gasoline and 400,000 tons for diesel. There are 2,000 fuel stations and 50 oil importer companies in Myanmar.—Ko Khant (Translated by Ei Myat Mon)

# Google checking account service on its way: report

SAN FRANCISCO — Google plans to launch a checking account service next year in a collaboration with Citigroup and a credit union in Silicon Valley, the Wall Street Journal reported on Wednesday.

In a project code named Cache, Google is working on a system that will host checking accounts clearly bearing the brands of the financial institutions, which will handle security and regulatory compliance issues, according to the Journal report. The report quoted a Google executive as saying the company's approach "is going to be to partner deeply with banks and the financial system" in what might be seen as a longer but safer route.

The move would come as internet titans become increasingly involved in online financial transactions and e-commerce.

Apple and Google both offer digital wallets that can be used on smartphones to

pay for purchases online or in real-world shops. Apple also recently released a credit card. Amazon has been reported to be in talks with banks about creating a checking account service.

Meanwhile, Facebook has been steadily building up e-commerce tools at the social network as well as the ability to send money using its messaging apps such as WhatsApp.

Facebook has gone a major step further, releasing controversial plans for a global cryptocurrency called Libra. Facebook had originally hoped to roll out Libra next year, but has met fierce resistance from regulators and governments who see it as a threat to their monetary sovereignty. The social media giant's chief executive Mark Zuckerberg last month opened the door to scaling back plans for Libra if it cannot win approval as a new currency for global exchanges.—AFP■

#### Chinese Taipei halts sales of three Huawei phones in wording row

TAIPEI — Chinese Taipei has suspended sales of three Huawei smartphone models that listed it as "Taiwan, China" for timezones and contacts — a designation the self-ruled, democratic island bristles at.

Starting Thursday, sales of Huawei's P30, P30 pro and Nova 5T models will be banned until the Chinese tech giant tweaks their operating system, Taiwan's National Communications Commission (NCC) said.

How Chinese Taipei is described is a hugely sensitive political issue. Beijing considers Chinese Taipei as part of its territory awaiting reunification, by force if necessary, even though the two sides have been governed separately for the last seven decades.—AFP

### NOTICE TO FILE INCOME TAX RETURN, ANNUAL SALARY STATEMENT AND ANNUAL COMMERCIAL TAX RETURN

- 1. Income Year or the Year in which Sale proceed or Receipt is accrued: Income year or the year in which sale proceed or receipt is accrued (reporting period), to file a return, is specified as follows-
  - (a) For state owned organizations and financial organizations including banks, form October 1, 2018 to September 30, 2019,
  - (b) **For individuals, partnerships and associations**, from April 1, 2019 to September 30, 2019
- 2. Return Receiving Offices: Current (old) taxpayers have to file the returns at relevant revenue offices where their taxation matters are administered. For the new taxpayers, foreign companies have to file at Medium Taxpayers' Office (2); Myanmar companies located in Yangon Region at Medium Taxpayer Office (4); Myanmar companies located in Mandalay Region, Sagaing Region and Union Territory at Medium Taxpayer Office (5); Myanmar Companies located in other state/regions at relevant Township Revenue Offices; and individual taxpayers at relevant Township Revenue Offices, respectively.
- 3. Methods of filing a return: Returns can be filed by either of the following two methods -
- (a) **Filing in person:** In the case of return filing in person, return is considered filed on the date it is stamped as received by the Department.
- (b) **Filing by Mail:** In the case of return filing by mail, return is considered filed on the date of the postmark.
- **4. Completing the Return:** Taxpayer is required to complete the return properly and he/she has to attest to the accuracy and completeness of the return.
- **5.** The Return must be signed by taxpayer. If a tax return or part of a tax return was prepared for reward by some other person, that paid-preparer must also sign the return.
- **6. Deadline for filing returns:** January 2, 2020 (Thursday) (Note: According to the relevant laws, the due date for return filing is December 31, 2019, the new year eve which is an international holiday. The following day, January 1, 2020 is also an International New Year Holiday. As per Section 19, Sub-section
- working day that is January 2, 2020.) **7. Penalties:** The following penalties shall be applied for non-compliance:
  - (a) A person who fails to file tax return on time is subject to a penalty equal to the greater of –

(a) of Tax Administration Law, the deadline has to be moved to the next succeeding

- (1) Five percent of the amount of tax owing, plus further one percent of the tax due for each month or part of a month during which the failure continues, but not beyond the time when the Director General issues an assessment; and
- (2) 100,000 MMK
- (b) In case of including an incorrect statement or omitting key information that lead to reduced tax due in the return as intentional conduct or negligence, the taxpayer is liable to a penalty in the amount of-
  - (1) 25 percent of the underpayment if the amount of the underpayment is less than 100,000,000 MMK or 50 percent of the person's tax liability, or
  - (2) 75 percent of the underpayment if the amount of the underpayment is more than 100,000,000 MMK or 50 percent of the person's tax liability.

#### Income Tax Return

- 8. Who has to File Income Tax Return: Companies, partnerships and joint-ventures, cooperatives, associations of collective farming, individuals (excluding salary-earners), associations formed by individuals, organizations or associations registered and formed under an existing law which are chargeable under Income Tax law are required to file their income tax return whether or not a profit was made during income year. Salary-earners are not required to file return.
- Supporting Documents to be Submitted: The following documents are required to submit –
  - (a) Taxpayers of Large Taxpayers' Office and Medium Taxpayers' Office (1) should prepare their returns by strictly following the instructions mentioned in the return template and are not required to submit financial statement.
  - (b) Taxpayers who are not registered with Large Taxpayers' Office or Medium Taxpayers' Office (1) and earn income from business are required to attach a financial statement for the relevant year including books of account kept, along with the income tax return.

#### **Annual Salary Statement**

**10.** Employer is required to prepare and file annual salary statement for a period of 6 months from April 1, 2019 to September 30, 2019 for his/her employees to the relevant Township Revenue Office before a specified date.

#### Annual Commercial Tax Return

Who has to File Annual Commercial Tax Return: Any person who has taxable proceed of sale or receipt within the stipulated time for carrying out any of the following economic activities are required to file annual commercial tax return that declares annual sale proceed or receipt from services -

  - (b) Importing,
  - (c) Trading,
  - (d) Providing services.

#### Republic of the Union of Myanmar Office of the President Anti-Money Laundering Order Order No. 45 / 2019

3<sup>rd</sup> Waning of Tazaungmon, 1381 ME (14 November 2019)

- 1. This order shall be called the Anti-Money Laundering Order.
- 2. The following expressions contained in this order shall have the meanings given hereunder:
  - (a) Banks and financial institutions mean banks and financial institutions established by the Myanmar Financial Institutions Law and other relevant laws. This expression includes commercial banks or development banks, credit societies, finance companies, securities exchange companies, money changers, microfinance institutions, insurance companies and other institutions that conduct one or more of the following activities as a business for or on behalf of a customer, including:
    - (1) Activities included under the Banks and Financial Institutions definition stated in the Anti-Money Laundering Law
    - (2) Financial Leasing
    - (3) Keeping safe deposit boxes, safe keeping of cash and managing cash or liquid securities on behalf of other persons.
  - (b) Physical presence means meaningful mind and management located within a country. The existence simply of a local agent or low-level staff does not constitute physical presence.
  - (c) Legal persons mean any entities other than natural persons that can establish a permanent customer relationship with a financial institution or otherwise own property. This expression also includes companies, corporations, joint ventures, bodies corporate, foundations, anstalt, partnerships, or associations, organizations of a group of persons and other relevantly similar entities...
  - (d) Legal arrangements refer to express trusts or other similar legal arrangements.
  - (e) Beneficial ownership is defined as per the definition included in the Anti- Money Laundering Law. This expression also includes the natural person(s) who ultimately owns or controls a customer and/or the natural person on whose behalf a transaction is being conducted. It also includes those persons who exercise ultimate effective control over a legal person or arrangement.
  - (f) Ultimate effective control means a situation in which ownership/control is exercised through a chain of ownership or by means of control other than direct control.
  - (g) Customer means the same as the expression defined in the Anti-Money Laundering Law. This expression also includes any person who has a business relationship with a Reporting Organization.
  - (h) Property means the same as the expression defined in the Anti-Money Laundering Law. This expression includes property of every kind, whether intangible, movable or immovable, however acquired, and legal documents or instruments in any form, including electronic or digital, evidencing title to, or interest in, such funds or other assets, including but not limited to, bank credits, travelers cheques, bank cheques, money orders, shares, securities, bonds, drafts, or letters of credit, and any

- interest, dividends or other income on or value accruing from or generated by such funds or other assets .
- (i) Proceeds of Crime or Money and property obtained by illegal means means the same as the expression defined in the Anti-Money Laundering Law. This expression also includes economic gains including income or other benefits derived from such proceeds from property and property converted or transformed, in whole or in part, into another property.
- (j) Negotiable instrument means the same as the expression defined in the Anti-Money Laundering Law. This expression also includes bearer negotiable instruments. Bearer negotiable instruments in bearer form such as: traveler's cheques; negotiable instruments including cheques, promissory notes and money orders that are either in bearer form, endorsed without restriction, made out to a fictitious payee, or otherwise in such form that title thereto passes upon delivery; and incomplete instruments signed, but with the payee's name omitted.
- (k) Wire or electronic transfer means the same as the expression defined in the Anti-Money Laundering Law. This expression also includes any transaction carried out on behalf of an originator through a financial institution by electronic means, with a view to making an amount of funds available to a beneficiary person at a beneficiary financial institution, irrespective of whether the originator and the beneficiary are the same person. It also includes cross-border and domestic wire or electronic transfers.
- (l) Cross-border wire or electronic transfer means any wire or electronic transfer where the ordering financial institution and beneficiary financial institution are located in different countries. This term also refers to any chain of wire or electronic transfer in which at least one of the financial institutions involved is located in a different country.
- (m) Domestic wire or electronic transfer means any wire or electronic transfer where the ordering financial institution and beneficiary financial institution are located in the same country. This term therefore refers to any chain of wire or electronic transfer that takes place entirely within the borders of a single country, even though the system used to transfer the payment message may be located in another country.
- (n) Designated non-financial businesses and professions mean the same as the expression defined in the Anti-Money Laundering Law. This expression also includes lawyers, notaries, other independent legal professionals and accountants, and sole practitioners, partners or employed professionals within professional firms.
- 3. The offences referred to in Chapter (3) of the Anti-Money Laundering Law include the following offences:
  - (a) offences relating to terrorism and financing of terrorism
  - (b) offences relating to trafficking in humans and migrant smuggling

- (c) offences relating to illicit trafficking of narcotic drugs and psychotropic substances
- (d) offences relating to illicit arms trafficking
- (e) offences relating to trafficking of stolen and other illicit goods
- (f) corruption
- (g) fraud
- (h) offences relating to counterfeit money
- (i) offences relating to counterfeit goods
- (j) offences relating to murder or causing grievous bodily harm
- (k) offences relating to kidnapping, illegal restraint and taking hostage
- (l) offences relating to robbery or theft
- (m) offences relating to smuggling
- (n) offences relating to extortion
- (o) offences relating to forgery
- (p) offences relating to converting or transferring any money and property knowing, or having reason to believe, that it is obtained from the commission of any offence, in order to disguise or conceal the source of such money and property, or with the intention of aiding a person involved in a predicate offence or after its commission to avoid the legal consequences of his actions
- (q) concealing or disguising the proceeds of crime of their true nature, source, location, inherent property, conversion or ownership, knowing or having reason to believe that they are obtained from committing an offence
- (r) obtaining, keeping in possession or using such profits, knowing or having reason to believe at the time of receipt that they are the proceeds of crime
- (s) attempting or conspiring, aiding, supporting, facilitating, abetting, providing, recruiting, managing, associating with or counseling the commission of an anti-money laundering offence including the abovementioned offences
- (t) being a member of an organized crime group that commits, attempts to commit or conspires to commit a money-laundering offence including the abovementioned offences
- (u) inciting a person to commit a money-laundering offence, or conspiring with or deliberately facilitating a person or persons to commit money-laundering
- (v) laundering money and property in Myanmar that is derived from committing an offence abroad where the act constitutes an offence in that country and would have constituted any of the abovementioned offences had the same act been committed in Myanmar.
- 4. The Financial Intelligence Unit referred to in Chapter (5) of the Anti-Money Laundering Law shall be operationally independent and autonomous by:
  - (a) having authority and capacity to carry out its functions freely, including the autonomous decision to analyze, request or forward or disseminate specific information
  - (b) being able to make arrangements or engage independently with other domestic competent authorities or foreign counterparts on the exchange of information

- (c) when it is located within the existing structure of another authority, having distinct core functions from those of the other authority; and
- (d) being able to obtain and deploy the resources needed to carry out its functions, on an individual or routine basis, free from any undue political, government or industry influence or interference which might compromise its operational independence.
- 5. The duties of Financial Intelligence Unit referred to in Chapter (5) of the Anti-Money Laundering Law, shall also include the following:
  - (a) shall receive, analyze and disseminate suspicious transaction reports submitted by reporting organizations, and other information related to money laundering, financing of terrorism and predicate offences
  - (b) shall conduct operational analysis, which focuses on individual cases and specific targets, activities or transactions, or on appropriate selected information, depending on the type and volume of the disclosures received and the expected use after dissemination
  - (c) shall conduct strategic analysis to deal with the trends and typologies related to money laundering and financing of terrorism
- 6. The Scrutiny Board described in Chapter (6) of the Anti-Money Laundering Law, shall collaborate with the Bureau of Special Investigations and shall conduct investigations.
- 7. The Bureau of Special Investigations collaborating with the Scrutiny Board shall have the following duties:
  - (a) shall investigate offences related to money laundering and terrorist financing, based on the results of the analysis shared by the Scrutiny Board or the results of the parallel financial investigations on the offences conducted by law enforcement agencies in accordance with the existing laws, or on other sources of information
  - (b) may apply interception measures, investigation powers and special investigation techniques as follows
    - (1) investigate, detect, search, seize, freeze or return the money and property under bond
    - (2) to arrange for a bond
    - (3) seal or prohibit the exhibit from being managed or accessed by any other means
    - (4) compel reporting organizations to produce financial records
    - (5) take steps to prevent actions that may affect or obstruct the State's ability to freeze, seize or recover property that is subject to confiscation
- 8. The Central Body shall issue orders to conduct the following duties not more than (3) months at a time according to the request of the Financial Intelligence Unit and the Bureau of Special Investigations:
  - (a) undercover operations
  - (b) controlled delivery
  - (c) access to bank accounts
  - (d) access to computer systems, networks and servers
  - (e) place under surveillance or intercept telephone lines, fax machines or electronic transmission

- or communication facilities
- obtain audio or video files of movements and behaviors or conversations
- (g) seize information relating to money laundering and financing of terrorism, notarized and private deeds, or banking, financial and business records
- Witnesses, informants, activists and their family members who give information of money and property with regard to money laundering and terrorist financing shall be protected under the laws, rules, procedures and directives in the following ways;
  - (a) Non-disclosure or limitations of the witness's testimony, not to input the witness's testimony in the court record;
  - (b) Non-disclosure or limitations of the identity of the witness;
  - (c) Without the approval of the witness, not to summon the witness to testify in proceeding;
  - (d) Not to use the witness's testimony in any conviction or in fact of decision;
- 10. Reporting organizations shall be prohibited from keeping anonymous accounts or accounts in obviously fictitious names.
- 11. The reporting organizations shall immediately report to the Financial Intelligence Unit when the money or property transaction is equal to or exceeds the threshold value.
- 12. The reporting organizations shall-
  - (a) conduct the following due diligence at appropriate times as prescribed under this order, on accounts and customers that existed prior to the enactment of the Law and the new ones, based on the products, services and their risk:
    - (1) conduct due diligence measures when the risk of money laundering and terrorist financing is identified as high risk of money laundering as a result of the risk assessment, conducting enhanced customer due diligence measures consistent with the identified risk, and determining whether or not the transactions or other activities are unusual or suspicious;
    - (2) conduct simplified due diligence measures consistent with the level of risk, if the customer is identified as low risk according to the risk assessment of money laundering or terrorist financing;
    - (3) terminating simplified due diligence measures on the customer under above sub-article
      (2) if the customer is suspected of money laundering or terrorist financing, or identified as high risk;
    - (4) conduct enhanced due diligence and simplified due diligence measures on the customer in accordance with the directives of the competent authority.
  - (b) Due diligence measures on the customer referred to in sub-article (a) shall be conducted under the following times and situations:
    - before carrying out transactions for a customer, or before opening an account or establishing a relationship;
    - (2) before carrying out a transaction for a customer who has no established relationship with the reporting organization, if the transaction is equal to or above the threshold amount of USD 15000 or equivalent amount

- in any currency or as from time to time defined by the Central Body, whether conducted as a single transaction or several connected transactions;
- (3) before carrying out a domestic and international wire or electronic transfer for a customer;
- (4) when there is doubt about the veracity or adequacy of the customer identification data obtained previously;
- (5) when there is suspicion that it is linked to money laundering or terrorist financing
- (c) If the value of transactions referred to in sub-article (b) is unknown at the time of operation, verification and identification in accordance with the provisions of sub-article (a) of such amount shall be made as soon as it is made known, or as soon as it has reached the threshold amount.
- (d) Customer due diligence measures under sub-article (a) shall be under -taken as follows:
  - (1) Identifying and verifying the customer's identity using independent and reliable independent sources, documents, data or information;
  - (2) collecting information on and understanding the purpose and intended nature of the business relationship;
  - (3) identifying the beneficial owner and taking all reasonable measures to verify the identity of the beneficial owner, and understanding the ownership and control structure of the company formation or legal person or legal arrangement,
  - (4) verify if a person acting on behalf of a person, company, organization or legal person or legal arrangements is so authorized, the authenticity of his identity and the legal status of the company, organization or legal arrangement; obtain information on the customer's name, legal structure, address, details of the directors; and specify Regulations that will have binding on the company or legal person or legal arrangements.
- 13. In the conduct of investigation into money laundering associated predicate offences, financing of terrorism offence, the relevant law enforcement agency can request for all relevant information held by the Financial Intelligent Unit, in accordance with the provisions the Anti-money Laundering Law.
- 14. According to sub-section (d), section 19, Chapter (8) of Anti-Money Laundering Law, the reporting organizations shall conduct due diligence base on beneficial owners of the customer and take reasonable measures to verify the identity of such persons, based on the following information:
  - (a) For legal person
    - (1) identity of the natural persons if any- as ownership interest can be so diversified that there are non-natural persons whether acting alone or together exercising control of the legal person or arrangement through ownership who ultimately have a controlling ownership interest in a legal person.
