National-level Committee on Prevention, Control and Treatment of COVID-19 Public Announcement regarding COVID-19 Second Wave Prevention 15th Waning of Second Waso, 1382 ME

(18 August 2020)

- 1. According to the news released by the World Health Organization at 9:30 pm Myanmar Standard Time on 18 August 2020, there have been about 21.5 million confirmed cases of COVID-19 globally, with over 0.76 million deaths, showing a gradual increase in the number of cases and fatalities.
- 2. India, bordering with Myanmar, recorded 2.6 million cases and its death toll stood at 50,921, ranking third in term of cases. Meanwhile, Bangladesh has topped over 270,000 and 3,657 deaths until now. The numbers of confirmed cases and deaths are increasing in these countries day by day.
- 3. Myanmar has seen a downward trend of COVID-19 infection in the first wave, and this is expected to end soon. There are 376 confirmed cases, with six deaths, and 331 recoveries reported in Myanmar up to this morning. From 18 June 2020 to now, Myanmar has reported 114 cases, of which only
- 2 were domestic transmissions and the remaining 112 were from overseas. People have played a vital role in these successful control measures against this pandemic with their strict adherence to the rules and directives.
- 4. However, it is seriously to be considered that more than half (61 per cent) of positive cases in Myanmar exhibited no symptoms of this disease. A lot of possibilities exist for a severe outbreak of the second wave due to the spread of infection in the wards/villages or the public from the patients with exhibiting no symptoms. Some neighbouring countries and developed countries are struggling to contain this viral disease again, although they have announced their successful control measures against the second wave and deaths.

VP U Henry Van Thio presides over coordination meeting on disaster preparedness, possible food shortages

Van Thio, in his capacity as Chairman of the National Disaster Management Committee, presided over a coordination meeting on tackling possible food shortages caused by severe flood and drought resulting from global climate changes. The meeting was held at the Ministry of Social Welfare, Relief and Resettlement.

The Vice President talked about the effects of climate change resulting in natural disasters such as strong winds, floods, severe heat and drought, as well as landslides and soil erosions more frequently in many places.

He also pointed out the deadly soil erosion and landslide cases at the Kyaik Thalan pagoda in SEE PAGE-3

Section 58 (d) in Hluttaw Election Law



IN accordance with section 58 (d) of the Hluttaw Election Law, no one is allowed to give speeches at meetings, instigation, writing, distribution of using posters or attempting by other means to disturb the voting or election. Anyone who is found guilty of or abet this act shall be punishable with imprisonment for a term not exceeding one year, or with fine not exceeding K100,000 (one hundred thousand Kyats), or with both.

UNION Minister for the Office of the Union Government U Min Thu conducted a field study with the relevant officials on 17 August and 18 August in Zabuthiri, Dekkhinathiri, Pobbathiri, Zeyathiri, Tatkon, Pyinmana, Lewe and Ottarathiri townships.

The Union Minister and party inspected the preparation of sub-election commissions in villages, wards and townships for the eligible voters can cast their votes for 2020 General Election and coordinated in the administrative process to support the preparation.

The Union Minister told the officials from the General Administration Department and

the election commissions that the field study was to find out the real difficulties and to coordinate for the complete and correct voter lists at the second voter lists announcement for the upcoming elections in November.

During the ceremony, Deputy Minister U Tin Myint delivered words of thanks.


The Ambassador handed over the technical

Advance voting process for local voters outside their constituencies in 2020 General Election

- Heads of trainings, schools, hospitals and jails are to contact the sub-election commissions to get documents of Form 15.
- They must return these documents to sub-commission of respective townships by 26 August 2020 after the documents are filled by the voters.
- Sub-election commission of respective townships must send ballot papers and envelopes for advance voting to the trainings, schools, hospitals and jails by 7 October 2020.
- Advance voting must be organized at trainings, schools, hospitals and jails on their appropriate day from 8 October 2020 to 21 October 2020.
- The envelopes containing ballot papers must be sent back to sub-election commission of respective townships by 4 pm on 8 November 2020.

- 5. The public strictly followed fundamental rules to prevent COVID-19 in March, April and May 2020 during the upward trend in domestic transmission. Still, people have relaxed their close adherence to the directives since mid-June.
- 6. If the country encountered the second wave of this disease with the risk of a large and uncontrollable outbreak, then there would be a wide range of negative impacts on many sectors such as health, economy, education, employment and livelihood.
- 7. The second wave of COVID-19, which has grave consequences, could be prevented by the public through protective measures.
- The committee, therefore, urges the public to closely abide by the following five rules and collaborate to prevent a COVID-19 second wave.
- (a) Totally (totally) avoid crowds unnecessarily.
- (b) Practise social or physical distancing, stay at least 6 feet, if possible, from other people.
- (c) When going outdoors, wear face masks systematically in public spaces and gatherings.
- (d) Wash hands at least 20 seconds with soap and water to kill the virus on the hands.
- (e) Fully cooperate in quarantine processes for the returnees from overseas and report on illegal returnees.

in Mawlamyine Township in 2018 and at Ma Lat Mountain in Paung Township in 2019 in Mon State; flood caused by damage to the spillway of the dam on Swa Creek in 2018, accident to the embankment of Shwe Gae sluice gate near Amarapura Township in 2020, and the recent landslide incident in Phakant.

While deaths and damages to infrastructure are significant losses for the country, the long term plans must be adopted to address the decline in agricultural products caused by flood and drought, the Vice President added.

He also advised keeping watch on the changing situations of neighbouring countries which could impact on Myanmar because of information, technology, products, employment, culture, economy and politics.

The Vice President said that the COVID-19 pandemic had posed many challenges in the health and economic sectors; it has impacted negatively on the employment situation; and the pandemic has placed a heavy burden on the economy. He added that climate changes could worsen these situations and that proper plans should be adopted to avoid bad experiences resulting

Myanmar needs to ensure food self-sufficiency and encourage export of agricultural produce by using agricultural techniques appropriate with climate change, giving technical assistance to farmers, creating local and foreign markets to promote the trade sector and coordinating with relevant ministries to lessen the losses from natural disasters.

He added that Myanmar formed a coordination body in

The Vice President concluded his speech with the remark that success in the agricultural sector could elevate the socio-economic status of the people as 70 per cent of the population live in rural areas.

Union Minister Dr Win Myat Aye, in his capacity as Vice-Chairperson of the National Disaster Management Committee, explained the committee's works and activities on resolving potential food insecurity caused by climate change, plans to provide social welfare services during natural disasters and using technology in preventive measures and collaborative efforts with other countries.

Committee members Union Ministers Dr Aung Thu, U Thant Sin Maung and Dr Than Myint, explained various matters including food production, food exports, damages caused by natural disasters, preparatory and preventive measures for natural disasters, combatting climate changes, building more dams, using water systematically, promoting trade, keeping food reserves, providing enough electricity, and building more roads and bridges for better transport.

Deputy Ministers U Maung Maung Win and U Soe Aung discussed matters related to planning and finance as well as preparing reports on how to resolve food insecurity caused by floods or droughts.

In his closing remarks, the Vice President said that environmental conservation is very significant for trying to protect natural disasters, including floods and droughts. He highlighted the importance of creating more arable lands to produce more crops, using the farmlands systematically, rainwater harvesting, the need to build more dams, and plans to maintain arable lands in optimum conditions. He said that modern freezing and refrigerated storages should be jointly built by the government and the private sector. He suggested that foods should be exported only if food security is guaranteed in the country. The Vice President concluded that by linking with the MSDP, a "master plan" must be drafted in order that plans to safeguard food security can be continuously and effectively carried out.

The meeting was attended by Union Ministers Dr Aung Thu, U Thant Sin Maung, Dr Than Myint and Dr Win Myat Aye, Deputy Ministers U Maung Maung Win and U Soe Aung, directors-general and officials.—MNA

15th Waning of Second Waso 1382 ME 18 August 2020

- 1. The National-Level Central Committee on Prevention, Control and Treatment of Coronavirus Disease 2019 (COVID-19) deems it necessary to continue implementing preventive measures to contain the spread of COVID-19 and made an announcement on 13 August 2020 that all directives, notifications, requests to the public, and orders issued by Union-level institutions and ministries regarding the prevention, control and treatment of COVID-19 until 15-8-2020 (excluding those that have been ordered to be eased) will be extended to 31 August 2020
- 2. An announcement was made on 10 July 2020 for the exemption of 75 units from the electricity bills of consumption from 1 July to 15 July when COVID-19 preventive measures were increased.
- 3. An additional exemption (free of charge) of 75 units will be deducted from the electricity bill from 16-7-2020 to 31-7-2020 as COVID-19 preventive measures were extended. Thus, a total of 150 units from domestic consumption between the dates of 1 July and 31 July 2020 will get exemption (free of charge) from the electricity bill.
- Due to economic and psychological hardships amid COVID-19, the exemption (free of charge) of 150 units from the electricity bills of consumption will be extended until 31 December 2020 from 1 August 2020.
- 5. All relevant households that have consumed from 1 to 150 units of electricity will have their meter bill and service fees exempted (free of charge) while consumption of 151 units and above will have K11,550 for 150 units deducted from the total meter bill.
- 6. Domestic consumption of 151 units and above will have to make payments according to the different levels of consumption rate. Local civil society organizations in the NGO category are the only type of non-domestic consumers that will have the exemption applied to them. The other non-domestic types will have to continue payments in regular rates.

All Tatmadaw MPs tested negative for COVID-19

All Tatmadaw Hluttaw representatives, who will attend the meetings of Second Pyidaungsu, Pyithu and Amyotha Hluttaws' 17th regular sessions, have tested negative for COVID-19, according to

the Tatmadaw True News Information Team's statement.

A total of 166 Tatmadaw Hluttaw representatives had their swabs tested at the Defence Services General Hospital in Nay Pyi Taw with COBAS 6800 machine on 17 August, and none of them tested positive for the virus. —MNA

Myanmar brings 109 nationals back home by relief flight

A relief flight of Myanmar National Airlines (MNA), from Incheon International Airport, Republic of Korea, landed at Yangon International Airport yesterday evening, bringing back 109 Myanmar nationals stranded in the foreign countries.

The returnees included 1 Myanmar national from United Arab Emirates-UAE while 1 from Czech Republic, 2 each from Austria, Viet Nam and Italy, 3 each from Switzerland and Brazil, 4 from Indonesia, 3 from UK, 4 from Canada, 5 each from Belgium and Egypt, 29 from the US, 28 from Republic of Korea, and 17 seamen.

The Ministry of Labour, Immigration and Population, the Ministry of Health and Sports, and local officials helped the returnees for health inspections



More than K31bln worth of ICE confiscated in Rakhine State

POLICE seized K31.74billion worth of crystal methamphetamine (ICE) on board a vessel near Kyeintali Township in Rakhine State on 16 August, according to Myanmar Police Force.

Acting on a tip-off, police raided a motor boat anchored near Maung Dauk Creek, which is about two miles away from south west of Kyeintali Township, in the afternoon of 16 August, and a total of 1,380 kilograms of ICE in 61 gunny sacks from the boat were confiscated.

During the raid, five men ran away from the boat swimming. Police arrested them later.

Of the suspects, Kyaw Moe Swe, Phyo Min Aung, San Lin, and Tun Tun Win were arrested on Thandwe-Kyeintali Road in the evening of the same day, and Maung Pu (a) Hla Ngwe near San Chaung Village in Gwa Township on the following day.

According to the police's investigation, the confiscated drugs taken from a ship near Kin Maw Village in Thandwe

Township are the things that will be transported to the territorial waters of Malaysia near Indonesia.

Suspect Tun Tun Win is incharge of the seized boat that was being anchored near the Maung Dauk Creek due to the strong winds on the sea.

Police filed a case against the suspects in connection with the case, and further investigation was underway.—MNA

To address gender-based violence amid COVID-19, we need creativity, collaboration and courage

ONE glaring truth the ongoing COVID-19 pandemic has reinforced when it comes to gender-based violence is that it is a humanitarian, development and socioeconomic crisis - a persistent and daunting triple threat whose solutions must be grounded in gender equality and human rights.

Even before the pandemic, gender-based violence was a debilitating challenge globally, with on average one out of three women experiencing some form of violence in her lifetime. In Asia and the Pacific the percentage of women disclosing experience of physical or sexual violence, or both, by an intimate partner ranged widely across different countries, from 15 per cent in places like Lao PDR and Japan to 64 per cent in several Pacific countries like Solomon Islands and Fiji

Not long after WHO declared a COVID-19 pandemic in March, UNFPA forecast that an estimated 31 million additional incidents of gender-based violence could be expected globally, if lockdowns last for at least six months, with women confined indoors with their abusers. For every three months such restrictions continue, an additional 15 million incidents could be expected.

We've already seen huge spikes in the numbers of women seeking support, including through calls to dedicated helplines. Resources to address gender-based violence, already stretched thin in many places before the pandemic, are all the more challenged now. And we know that this escalating violence will have long-term and first aid and referral support to

damaging socioeconomic consequences on women's health, safety, security and economic

Another truth that's also been revealed is that responding to gender-based violence in the context of unprecedented challenge requires creativity, collaboration and courage – as displayed by the humanitarian heroes supporting survivors in so many different ways in country after country, no matter how difficult the circumstances.

In Nepal, teams of community psychosocial workers already present in remote far-western and eastern rural districts before the pandemic are being provided with additional air-time on their mobile phones to step up psychological

survivors, connecting them to locally available services. Saraswati Rai Chaudhury and her colleagues roam far and wide to also reach migrant workers in quarantine centres, mothers' groups and their children, relatives of COVID-19 patients and elderly people. Since Nepal's lockdown began, more than 4,500 women have been

For refugees in the sprawling camps of Cox's Bazar, Bangladesh, service providers have expanded the support available in women-friendly spaces to include midwives like Tania Akter alongside psychosocial counsellors, integrating essential gender-based violence and sexual and reproductive health services under one roof. A huge COVID-19 worldwide have been frontline health workers like Tania who put themselves at risk, working long, gruelling hours to meet demand and needs, and sacrificing time away from their loved ones for months on end.

In Myanmar, realizing the

crucial need to scale-up services, government, civil society and UN partners came together to boost helplines by training responders to provide immediate remote psychological first aid, as well as directing callers to women support centres which are safe spaces, linking up women to various types of assistance. Also, many health actors have been trained and mobilised to support survivors.

After earthquakes struck the Philippine province of North proportion of those contracting Cotobato last year, local organcentres that included timely and quality care gender-based violence response services, helping women navigate the local system to seek lifesaving support. Availing of this extended support into the pandemic, dozens of Filipino women are now benefitting through these centres from a new initiative called Cash for Protection which provides 10,000 PHP (~USD 200) as part of a wider social safety net for survivors.

In Rawalpindi, Pakistan, the Women Safety smartphone app, introduced two years ago, was urgently upgraded by the Punjab Safe Cities Authority (PSCA) earlier this year as pandemic lockdowns intensified. Women who install the app can alert the police on an emergency helpline or send a text via WhatsApp to the PSCA. As soon as the message with location coordinates is received, designated teams are mobilised for an immediate response, heading to the caller's precise location.

We've learnt useful lessons and promising practices - from the numerous critical interventions led by humanitarian heroes like Saraswati, Tania and so many others.

Firstly, services to support survivors of gender-based violence are truly lifesaving and more crucial than ever. Governments cannot and must not compromise or sacrifice this support when funding the pandemic response. It's quite literally a matter of life and death for thousands upon thousands of women and girls.

Second, national governments must invest much more in gender-based violence pre**By Bjorn Andersson**

vention and response resources, including a skilled and empowered workforce of frontline service providers. This will build on a regional and global evidence base of what works to create a strong foundation, so that this lifesaving work can be quickly expanded during emergencies like COVID-19.

Third, necessity is indeed the mother of invention. Some of the most effective interventions we've seen embrace creative thinking despite COV-ID-19-related restrictions, as well as adapt user-friendly technology to reach gender-based violence survivors safely. In this, partnerships between government, civil society and the private sector are key to ensure we innovate to reach the most vulnerable and marginalized.

Fourth, but not least, countries can and should learn from one another by sharing what

We've heard a lot about the post-COVID-19 need to build back better to ensure no one is left behind.

To convert rhetoric into reality, we must all prioritize the health and wellbeing of women and girls - from achieving optimal sexual and reproductive health to ending gender-based violence and harmful practices - beginning now.

"We must redouble efforts to stop the virus from moving into vulnerable communities," Kasai

Some countries that had brought their outbreaks under control -- such as New Zealand. Vietnam and South Korea -- have detected new clusters, forcing governments to reimpose painful lockdowns on cities and tighten social distancing rules.

But Kasai said the use of targeted interventions in the region was encouraging because it reduced the economic and social impact of containment measures and was more sustainable.

He warned, however, that the challenge will remain "as long as the virus is circulating and we don't have immunity to it".

Sixth ship carrying rails for Nyaunglebin-Toungoo railway docks in Sule Wharf

THE 6th ship named MV Ginto carrying rails from Japan to use in CP-103 Nyaunglebin-Toungoo railway docked at Sule No 5 Wharf on 17 August, according to Myanma Railways (MR).

MR is upgrading Yangon-Mandalay railway, which is 385 miles in length with JICA's official development assistance (ODA) loans to ensure the convenience of the train commuters.

"The 6th ship reached Myanmar carrying 2,997.035 tonnes of railway tracks which are 82 feet long. Although Myanma Railways has planned to unload them from the ship on that night, the rails will be unloaded depending upon the weather condition because there are heavy rains in Yangon Region these days," said U Kyaw Kyaw Oo, the Assistant Manager from MR.

"The unloaded rail tracks

will be carried by coaches to Ywarthagyi dry port. Then, the rails will be transported to the project areas. Normally, MR is running 12 coaches from Sule port to dry port. About six coach-

es will be needed to carry the rail tracks to reach the project areas in the dry port," he added. MR is reportedly upgrading the railway project in two phases — Yangon-Toungoo railway, which

is 166 miles in length and Toungoo-Mandalay railway, which is 219.5 miles in length. —Soe Myint Aung

Govt to provide 872-tonne palm oil to over 4 mln residents in Magway

THE government stockpiles 50,000 tonnes of rice and 12,000 tonnes of palm oil as reserved foodstuffs

for the emergency during the pandemic period to provide them to their citizens. Then, the government will distribute over 54,000 palm oil boxes weighing 872 tonnes to over 4 million people in Magway Region, according to the Regional Consumer Affairs Department.

The reserved rice bags are stocked in Yangon, Mandalay and Nay Pyi Taw and the palm oil is distributed to the states and regions. Now, the palm oil has reached the Magway Region and is stockpiled in the five districts in Magway Region.

"The government supports to prevent a shortage of food for the public if the outbreak of coronavirus is highly spread in the country. We are ready to distribute the ration if we get the permission," said U Myint Win, the regional head from the Consumer Affairs Department.

According to 2018-2019 official statistics, there are around 3.9 million residents in Magway Region. This year, there are over 4 million people in Magway Region, according to the statistics of the Immigration Department and wards and villages-based lists. This distribution of the ration lists is based on 3.9 million people. So, we can distribute 12 kyattha (1 kyattha = 16.33 gram) to each person, he highlighted. —Zayyatu (Magway)

Sufficient rain helps sesame high yield in Magway

SOME villages in Magway Region get a high yield of sesame thanks to sufficient rainfall, according to the local sesame growers.

However, over 0.13 million out of over 1 million sesame plants were damaged in the Magway Region because of the drought.

"The production of black sesame in our village is normal. Each acre of black sesame has produced around ten baskets, whereas that of the white sesame has produced around 15 baskets. We are fortunate that we get sufficient rainfall," said U Myint Soe, a local farmer from Sipintha Village in Magway Township.

The price of black sesame is K70,000 per basket while the white sesame is sold for K48,000 per basket in the market. It does not mean we get a good price.

However, it is a fair price, said U Thaung, a local sesame grower.

Sesame is cultivated in the country throughout the year Magway Region, which has gained a reputation as the oil pot of Myanmar, is the leading producer of sesame seeds. The seeds are also grown in Mandalay and Sagaing regions.

Myanmar exports 90 per cent of sesame production to foreign markets. China is the primary buyer of Myanmar sesame, which is also shipped to markets in Japan, South Korea, China (Taipei), UK, Germany, the Netherlands, Greece, and Poland among the EU countries.

The EU markets prefer organic-farming sesame seeds from Myanmar, said an official from the Trade Promotion Organization.

Regional trade tops \$9.94 bln this FY, reports Ministry of Commerce

THE value of Myanmar trade with ASEAN countries through the sea route and land borders has registered at US\$9.94 billion in the nine months (Oct-June) of the 2019-2020 financial year, according to the Ministry of Commerce.

The ministry reported that imports surpassed exports in regional trade, with exports reaching over \$3.6 billion and imports valued at over \$6.32 billion.

Since October, Thailand has been Myanmar's largest trade

partner in ASEAN, with trade valued at \$3.9 billion, followed by Singapore (\$3.3 billion), Malaysia (over \$1 billion) and Indonesia (\$936.5 million). Viet Nam has emerged as the nation's fifth-largest trade partner, with bilateral trade estimated at \$609.47 million.

Meanwhile, Myanmar bilateral trade with the Philippines was \$122.74 million, Cambodia \$25.7 million, while trade with Laos stood at \$1.3 million, and Brunei, less than \$1 million.

Myanmar main export items

included agricultural and fishery products, as well as minerals, while imports included food and beverages, electronic tools, motor vehicles, and consumer goods. Apart from its leading trade partner China, Myanmar mostly carried out its external trade with regional partners. Trade with countries in the European Union, however, remained uncompetitive, compared with the Southeast Asian trade partners. — GNLM

Sino-Myanmar bilateral trade worth \$9.17 bln in Oct-June

The value of Myanmar trade with China through maritime trade channels totalled over US\$9.17 billion in October and June of 2019-2020FY, including \$4.03 billion worth of exports and \$5.13 billion for import, according to the data released by the Ministry of Commerce.

Myanmar primarily exports agro products to China through

the borders. However, trade of agricultural products is frequently halted on account of China clamping down on illegal trade in border crossings. China has been stepping up border control measures to contain the spread of the coronavirus, causing traffic congestion in the border areas of two sides and delays.

In a bid to lower trade barri-

ers and offer relief to Myanmar traders through the border trade channel, the Ministry of Commerce, the related departments and Union of Myanmar Federation of Chambers of Commerce and Industry have been negotiating with China counterparts.

The two countries are making efforts to set up more border economic cooperation zones and promote border trade.

The value of bilateral trade with China was \$11.39 billion in the 2018-2019FY, \$6 billion in the 2018 mini-budget period, \$11.78 billion in the 2017-2018FY and \$10.8 billion in the 2016-2017FY respectively.

Rice, various types of peas, sesame seeds, corn, fruits and vegetables, dried tea leaves, fishery products, rubber, minerals and animal products are exported to China. In contrast, machinery, plastic raw materials, consumer products and electronic tools flow into Myanmar.—GNLM

Myanmar Rubber Forum to be held in Yangon

MYANMAR Rubber Forum for sustainable rubber value chain development will be held in Yangon during September, said U Khaing Myint, secretary of Myanmar Rubber Planters and Producers Association (MRPPA).

The objectives behind the forum are to bring about the sustainable development of those stakeholders in the value chain, to boost the competitiveness of the farmers, producers and Technically Specified Rubber factories, and to get a reasonable price and maintain quality.

"We are prepping for the forum. Sure, we must follow the health guidelines issued by the Ministry of Health and Sports. The event is likely to take place in September. We are making efforts to hold the event at the soonest," he said.

At present, Myanmar rubber raw materials are offered a lower price than that in the international market as they do not meet international standard, he continued.

"Myanmar rubber is priced only 300-350 per tonne, whereas the international price fetches about US\$1,600 per tonne. We have to reduce the price as they are of low quality," he added.

During 5 August, Union Minister Dr Than Myint of the Ministry of Commerce met the officials from MRPPA at the meeting hall of the ministry. During the meeting, the Union Minister gave the remark that the ministry has supported the technical requirement to some extent to have quality rubber export. Furthermore, it will employ more laboratory staff and extend the lab facilities for the development of the rubber industry.

Additionally, they discussed receiving the technical assistance by connecting with development partner like Japan International Cooperation Agency for the rubber sector development.

The Ministry of Commerce (MOC) and MRPPA signed a Memorandum of Understanding (MoU) in 2016 and set up Myanmar Natural Rubber Quality Testing Lab at the Commodity Testing and Quality Management Division (Hlegu Township) of the Consumer Affairs Department under the MOC.

Malaysia Rubber Board audited the lab in December 2016, and the lab passed Round Robin Test (or) Proficiency Test four times in 2017. International Rubber Association will accredit it.

There are over 1.6 million acres of rubber plantations in Myanmar, and 800,00 of them can be processed latex. Myanmar exports over 200,000 tonnes of rubber raw materials to the external market per year.

MoC restricts 6 export items including minerals

SIX items, including minerals, livestock and animal products, and general commodities, are not allowed to be exported by overseas, air cargo and land border under section 13 (B) of the Export and Import Law, stated the Ministry of Commerce in its notification issued on 17 August.

The goods prohibited are diamond, crude oil, ivory and elephant, horse, rare animals, ancient products and ammunition.

The Commerce Ministry restricted 31 items by maritime trade and 32 through land borders under the Law Order 10/1999 on 16 November 1999. The commodities prohibited to export have been amended in line with the situation of local market conditions, with 15 items allowed in 2008 and more things in 2001, 2014, 2016, 2017 and 2018. —GNLM

Libya unity govt signs military accord with Qatar, Turkey

TRIPOLI—Qatar and Turkey have signed an accord to send military advisers and instructors for the armed forces of Libya's Government of National Accord, the UN-recognized GNA said.

"We have reached an agreement with Turkish Defence Minister Hulusi Akar and Qatar's (minister) Khaled bin Mohammad Al-Attiyah on tripartite cooperation to build a military institute for training," said the GNA's deputy defence minister, Salah al-Namrouch.

Both Sheikh Khaled, Qatar's minister of state for defence, and Akar were in Tripoli on Monday for meetings with the GNA's military and for talks on three-way military cooperation.

Under the accord between the three countries, Turkey and Qatar will send military advisers and provide training at their military academies for Libyan cadets, Namrouch said.

Also visiting Tripoli on Monday, German Foreign Minister Heiko Maas warned that Libya faces a "deceptive calm" since fighting stalled in June around the coastal city of Sirte. Outside powers are "continuing to massively arm the country", said Maas, whose government has tried to broker peace in the wartorn North African country.

"In Libya at the moment we are observing a deceptive calm,"

he told journalists in Tripoli, seat of the GNA. Libya has been in chaos since a Western-backed uprising toppled and killed longtime dictator Moamer Kadhafi in 2011.

Eastern-based military commander Khalifa Haftar launched an offensive in April 2019 to seize Tripoli. After 14 months of fierce fighting, the Turkish-backed pro-GNA forces expelled Haftar's troops from much of western Libya and pushed them eastwards to Sirte, a gateway to Libya's rich oil fields and export terminals.

While the GNA has also been supported by Qatar, Haftar has had the backing of the United Arab Emirates, Egypt, Saudi Arabia and Russia.—AFP ■

Tribunal set to deliver verdict in 2005 Hariri murder case

BEIRUT—A UN-backed tribunal will hand down its verdict Tuesday on the 2005 murder of former premier Rafic Hariri, two weeks after the Lebanese capital was rocked by a massive explosion.

The Special Tribunal for Lebanon's long-awaited judgement comes days after a cataclysmic blast at Beirut port blamed on state negligence left at least 177 people dead and deepened public distrust toward the government.

Initially scheduled for August 7, the Dutch-based international court postponed its own verdict 15 years after Hariri's assassination "out of respect for the countless victims".

Four alleged members of the powerful Shiite Muslim group Hezbollah were on trial in absentia at the court in the Netherlands over the huge Beirut suicide bombing on 14 February 2005 that killed Sunni billionaire Hariri and 21 other people.

The judgment harks back to an event that changed the face of the Middle East, with Hariri's assassination triggering a wave of demonstrations that pushed Syrian forces out of Lebanon after 30 years.

The court is billed as the world's first international tribunal set up to probe terrorist crimes, and it has cost at least \$600 million since it opened its doors in 2009 following a UN Security Council resolution.

But the tribunal faces doubts over its credibility with Hezbollah chief Hassan Nasrallah refusing to hand over the defendants, and the case relying almost entirely on mobile phone records.—AFP

Israeli planes bomb Gaza as Egyptians seek to restore calm

JERUSALEM—Israeli warplanes pounded Hamas-ruled Gaza early Tuesday in response to Palestinian fire balloon attacks across the border, the Israeli army said.

The strikes came as visiting Egyptian security officials strove to defuse the latest uptick in violence, a Hamas source said.

"Fighter jets and (other) aircraft struck underground infrastructures belonging to the Hamas terror organization in the Gaza Strip," an Israeli military statement said.

It linked the air strikes to "explosive and arson balloons launched from the Gaza Strip into Israel".

The Hamas source told AFP the Islamists had held talks with the Egyptian delegation in Gaza on Monday before it left the territory for meetings with the Israelis and the West Bank-based Palestinian Authority.

It was expected to return to Gaza after those talks were concluded, the source added.

Despite a truce last year backed by Egypt, the UN and Qatar, Hamas and Israel clash sporadically, with Palestinian incendiary balloons or rocket or mortar fire drawing retaliatory Israeli strikes.

"The occupation continued its aggression and carried out air strikes on Gaza after midnight," the Hamas source said, adding that the strikes were seen as a "negative response" to the truce feelers. There were no casualties in the strikes, he added.—AFP

Anti-government protesters defy virus measures in Argentina

BUENOS AIRES—Thousands of opposition demonstrators took to the streets in cities across Argentina on Monday to protest against President Alberto Fernandez and his plans to extend confinement measures against the coronavirus.

Demonstrators defied social distancing rules to answer calls to protest against a government announcement last Friday to extend containment measures in the Buenos Aires region until August 30.

The capital is home to 90 percent of the country's growing coronavirus caseload.

Demonstrators shouting "freedom, freedom" gathered around the landmark Obelisk in central Buenos Aires, waving Argentine flags and chanting anti-government slogans.

Demonstrators also protested against Fernandez's planned judicial reform to expand the number of federal courts in an effort to dilute the influence of judges suspected of making politically motivated decisions.

The protests in Buenos Aires and other main cities took place despite a recent easing of restrictions, even as the country battles a steady rise in infections.—AFP

Huawei's Meng seeks classified docs in extradition fight

VANCOUVER—Huawei executive Meng Wanzhou's lawyers went to court on Monday to press for the release of classified documents related to her arrest that they claim will show her rights were violated.

Meng, the Chinese

telecom giant's chief financial officer, was arrested on a US warrant in December 2018 during a stopover in Vancouver.

She is charged with bank fraud related to violations of US sanctions against Iran, and has been fighting extradition

Appearing by teleconference at the British Columbia Supreme Court, defence lawyers said the Crown must not be allowed to shield authorities' misconduct by blocking the release of key documents.—AFP■

S.Korea's auto export keeps falling for 4 months

SEOUL—South Korea's automotive export kept falling for four straight months through July due to an economic fallout from the COVID-19 pandemic, a government report showed Monday.

The number of locally-made cars exported in July was 181,362, down 11.7 per cent compared to the same month of last year, according to the Ministry of Trade, Industry and Energy. It continued to retreat for four months in a row, but the sliding pace slowed from declines of $44.6\,per\,cent\,in\,April, 57.5\,per\,cent\,in\,May$ and 40.1 per cent in June respectively.

The slowing export fall came as car demand increased from North America and Europe, caused by the reopening of businesses in major economies after lockdowns on worry over the COVID-19 pandemic. In terms of value, the auto export slipped 4.2 per cent over the year to 3.66 billion U.S. dollars in July. It was lower than reductions of 36.3 per cent in April, 54.1 per cent in May and 33.2 per cent in June each.

The number of car sale in the domestic market 164,539 in July, up 8.9 per cent from a year earlier. The local car sale kept growing for the fifth consecutive month owing to the launch of new models and the discount event.-Xinhua

China launches anti-dumping investigation into Australian wine

BEIJING—China on Tuesday ramped up tensions with Australia as it launched a probe into wine imports from the country, the latest salvo in an increasingly bitter row between the trade partners.

Relations between Beijing and Canberra have nosedived in recent months after Australian

Prime Minister Scott Morrison joined US calls for an independent inquiry into the coronavirus pandemic, which was first detected in the Chinese city of Wuhan last year.

China, Australia's biggest trade partner, has since threatened economic blowback on a range of Australian goods including beef

and barley as well as tourism and higher education.

The ministry of commerce said in a statement it would investigate dumping -- when a country sells goods in a country for less than it costs at home -- throughout 2019, at the request of the Wine Industry Association of China.—

Walmart profits boosted by e-commerce, US stimulus payments

The world's biggest retailer cited robust demand for groceries and heavy use of e-commerce from home-bound consumers. Sales were strong for electronics, outdoor living items and other goods with higher profit margins, the company said.—AFP ■

Myanmar's border trade with neighbouring countries sees US\$ 8.6 billion

YANMAR'S border trade with neighbouring countries reached US\$8.6 billion as of late July in the current financial year, an increase of over US\$280 million compared to the same period of last financial year, according to figures from the Ministry of Commerce. Myanmar's border trade with its neighbours was US\$8.3 billion in the same period of financial year 2018-2019, the ministry said.

Myanmar's export volume through its borders fetched

US\$5.8 billion while the country's import reached over US\$2.7 billion. Muse border saw the largest volume and value of Myanmar's total border trade, with an estimated value of over US\$5.4 billion, followed by Myawady with US\$858 million and Chinshwehaw with US\$554 million during that period. The Sino-Myanmar border trade through all five border crossings has registered over US\$4.7 billion in the current financial year, a decrease of US\$123.5 million compared to the same period of last financial

year, according to the ministry's statistics. Muse topped the list of border checkpoints with the most trade value of US\$3.8 billion, followed by Heekhee with US\$ 1.6 billion, the ministry's data showed.

Myanmar's border trade with China was recorded over US\$ 4.83 billion in the year-ago period. Border trade with China was valued at US\$3.89 billion through Muse border gate in this FY, US\$123.35 million via Lweje, US\$430.7 million via Chinshwehaw, US\$263 million

via Kampaiti, and over US\$4.45 million via Kengtung. The decline in bilateral trade is attributed to the suspension and delay of some commodities amid the tight

security measures of coronavirus. China has been beefing up border control measures to curb the spread of the coronavirus infection. China's investment



in Myanmar during the period from 1988 to date was valued at more than US\$20 billion which is equivalent to about 26 per cent of total FDI in the country.

The trade volume between Myanmar and Thailand has reached US\$2.71 billion in total, a decrease of US\$103.9 million compared to the same period of last year, according to ministry. The bilateral border trade saw US\$2.82 billion in last year. Myanmar-Thailand border trade totalled US\$2.711 billion between 1 October last year and early this year, which included US\$1.95 billion in exports and US\$757 million in imports. The Hteekhee border recorded the highest trade value of US\$1.35 billion, followed by Myawady with US\$820 million and Kawthoung with US\$299 million. The country mainly conducts border trade with Thailand via seven borders Tachilek, Myawady, Kawthoung, Myeik, Hteekhee, Mawtaung and Mese checkpoints.

Meanwhile, Myanmar-India border trade is down by over 40% for the current financial year due to the temporary closure of border posts amid the ongoing COVID-19 pandemic. The trade value went down from US\$128 million to US\$76 million for the same period, a decrease of 40% compared to the same period of last financial year. The two countries conduct border trade mainly through the Tamu, Reed, Thantlang, and Kenglap

cross-border trade camps, while a major part of bilateral trade is carried out via the sea. India is one of Myanmar's top trading partners and the two countries inked a bilateral border trade agreement in 1994.

Myanmar-Bangladesh bilateral trade via border checkpoints was valued at over US\$747.63 million as of 26 June in the current 2019-2020 financial year, an increase of US\$730 million from the corresponding period of last year. When compared with last FY, this FY saw a significant surge in the value of exports by US\$427.42 million while the bilateral imports rose by US\$302.96 million. Between 1 October last year and 26 June this year, Myanmar transported commodities worth US\$443.4 million to Bangladesh and imported goods valued at over US\$304.2 million. Myanmar exports goods to Bangladesh through both maritime and land routes.

Myanmar mainly exports agricultural products, animal products, marine products, minerals, forest products, manufacturing goods and others while capital goods, intermediate goods to neighbouring countries and consumer goods, machinery and medicine are imported to the country. Around 20 percent of Myanmar's total trade is conducted through its border crossings and the remaining 80 per cent is done by sea route.
