The meeting approved 10 new investment projects in electricity, industry, hotels and tourism and livestock and fishery sectors including enhancing capital investment of (10) projects. The investment volume of said projects is 446.158 million USD and over 254.951 billion kyats, and it will create 7,640 job opportunities. Renewable energy productions were also included in the permitted projects. anmar, Singapore, China and Thailand are largest investors until June 2023. The most investment sector is electric power with 28.25%, followed by oil and natural gas with 24.59% and industry sector with 14.39 %.

Myanmar Investment Commission conducts scrutinizing and permitting the investment proposals submitted by local and foreign investors and investment service for the investors in line with the law, it is reported.

Myanmar's Response to Report of United Nations Secretary-General on Conflict-related Sexual Violence and its Open Debate

The United Nations Security Council held the annual open debate on conflictrelated sexual violence on 14 July 2023 in which Myanmar Armed Forces (Tatmadaw) is listed yet again in the annexe of the report. In this regards, Myanmar responded to the such annex of the report.

Response

The annual report of the United Nations Secretary-General on Conflict-related Sexual Violence for the year 2022, which includes country-specific descriptions of 17 countries including Myanmar, was released and the Security Council held the annual open debate on conflict-related sexual violence on 14 July 2023.

It is disappointing to observe that Myanmar Armed Forces (Tatmadaw) is listed yet again in the annexe of the report. Myanmar views it as an act of sheer politicization. The United Nations independent experts need to take into account the information provided by the State concerned and all information needs to be cross-checked to the best extent possible. However, the report not only deliberately excluded the information provided by the Government but also failed to verify the accuracy of the alleged cases with the concerned country.

Myanmar has been listed in the annexe of the annual report of the United Nations Secretary-General on Conflict-related Sexual Violence since 2018, based on the allegations of sexual violence that reportedly occurred in the Northern Rakhine State in 2017. Nonetheless, there is no concrete evidence to prove the perpetrators of such crimes. Yet the annual report contains unfounded allegations from anti-government sources without meaningful facts such as venue, date and time or any other relevant information to verify the alleged incidents. On the other hand, this year's report informs about cases of sexual violence in the camps in Cox's Bazar and how these cases are referred to male camp leaders who favour harmful dispute-resolution approaches. In fact, such cases have been prevalent unfortunately as rape cases against a total of over forty women by a camp leader were filed by six complainants from an IDP camp in Sittway earlier this year. The cases which were reportedly taken place between 2012 and 2022.

The report itself admits that no complaint was received but made its own conclusion as "underreported" based on speculations. Even though sexual violence cases committed by the terrorist group PDF went viral, failure to include such information makes the report further unbalanced. It is reported that four members of the so-called PDF raped and murdered a total of seven persons including four girls in August 2022 in Pekatoe Village of

Chaung Oo Township in Sagaing Region.

The report further misleads the international community by excluding a long list of measures taken by the Government to prevent conflict-related sexual violence. With the aim of delisting Myanmar from the annexe of the said report, the Joint Communique on Prevention and Response to Conflict-Related Sexual Violence was signed between Myanmar and the United Nations on 7 December 2018. The National Committee on Prevention and Response to Conflict-Related Sexual Violence was also established on 26 March 2019. The State Administration Council reconstituted the National Committee on 31 March 2021. The National Action Plan on Prevention and Response to Conflict-related Sexual Violence was adopted in June 2021 and the inputs provided by the Special Representative were appropriately incorporated in it. Myanmar also shared its National Action Plan with the Special Representative and progress in its implementation was also updated to her properly. The Action Plan has been extended to another year till 10 November 2023.

Myanmar is a society which traditionally and culturally opposes sexual violence in any form. It is well recognized that military personnel are strictly required to abide by the code of conduct as the offenders were punished to maximum sentences in accordance with a zero -tolerance policy. The Office of the Adjutant General issued a directive with letter No 1/85/727/Yay 3 (ga nge) dated 24 November 2021 to prevent conflict-related sexual violence. The instructions have been made known to all levels of the Tatmadaw which has been strictly monitoring the compliance of the instructions. The Office of the Judge Advocate-General and military academies have conducted a series of education trainings which includes inter alia, awareness raising for prevention of sexual violence. The trainings were participated by a total of over 43,000 military personnel in 2022.

In connection with the allegations against the detention centres, complaints can be filed with the respective Departments or the Myanmar National Human Rights Commission. The Commission has made a total of 41 prison visits from 2021 to May 2023 to inspect whether treatments are in line with the United Nations Standard Minimum Rules for the Treatment of Prisoners.

In addition to the helpline phone established in 2016, Viber messages and Facebook channels were extended to file complaints on different forms of violence against women in January 2022. Moreover, five One Stop Women Support Centres (OSWSCs) have been established since 2017 and expanded to two States and Regions in 2021 and 2022. The OSWSCs provide necessary support including temporary shelter, legal aid and psychosocial support to survivors from gender-based violence. In the same vein, seven One Stop Crisis Centres (OSCCs) have been established by the Ministry of Health since March 2022 in seven general hospitals in four States and Regions to provide healthcare services.

It is also found out that Kyaw Moe Tun, a dismissed civil servant who has been facing a charge of high treason, participated in the said open debate and made a misleading statement. Myanmar registered its strong objection with relevant UN Offices against his participation and statement which does not represent the country. Myanmar also objects to some irresponsible and one-sided remarks by certain countries at the event.

Continued putting Myanmar on the list of the annexe of the report without any significant cases is a clear act of politicization and selectively targeting Myanmar. The unsoundness and unevenness of elements in the report are literal proof that the report is a mere attempt to discredit Myanmar on political grounds. Myanmar firmly believes that it should be delisted from the annexe of the report since the allegations cannot substantiate, perpetrators were given maximum penalties and domestic mechanisms are put in place to prevent conflict-related sexual violence.

Answers of SAC Information Team Leader Maj-Gen Zaw Min Tun on Printing and Distribution of "twenty-thousand-kyat" New Myanmar Currency



Regarding the question raised by a reporter on the printing and distribution of "twenty-thousand-kyat" new Myanmar currency, the Leader of the Information Team of the State Administration Council (SAC) Maj-Gen Zaw Min Tun replied to a question that the people can operate for their socioeconomic development without any concerns. 18

Q: I would like to raise a question related to the printing and distribution of Myanmar currency notes of "twenty-thousand-kyat" on 23 July 2023. People are worried about hiking prices of foreign exchange rates and gold prices because of the printing and distribution of twenty thousand currency notes. So, how do you clarify current situations to the government and the people?

A: We enquired about the root causes of such an event. First, we found it as rumours. I would like to firstly explain the spreading of rumours. The Central Bank of Myanmar announced 8 am yesterday concerning the circulation of a new currency twenty-thousand note. In mid-day, two rumours came out. The first rumour was the circulation of twentythousand-kyat notes; more currency notes may come out; higher valued currency notes may emerge; Myanmar currency value will decline; and it may cause a high inflation rate. One more item of rumour came out a few hours later. Such a rumour was intentionally spread that existing currency notes may be revoked. As that day was Sunday, the forex rate of the US dollar gradually increased and the gold price rose as well. As it was an office holiday, the US dollar exchange rate was slightly high due to the lack of exchanging currencies practically. The gold price was also sharply high. This morning, the Central Bank of Myanmar issued a press release on the Q&A session for public observation. Such a Q&A session showed comprehensive facts and data. After the CBM issued it at about 9 am, one more rumour came out between 10:30 am and 11 am. Such a rumour was based on some parts of the Q&A session of the CBM. It showed that everybody can take three twenty thousand currency notes each. Moreover, it mentioned that a large number of such currency notes based on the Myanmar population have been printed and published. At the same time, some exile media mentioned the fabricated stories presented by a Myanmar economic observer. The rumour carried that it was not good in the economic situation as the government published new currency notes. Consequently, the US dollar exchange rate and prices of gold were high. Later, prices of other commodities were also raised. As a main reason to cause such an event, the CBM issued an announcement on 23 July 2023, regarding the export and import measures. Once, an announcement was mentioned that 65 per cent of earnings from export must be exchanged with Myanmar currency. The Chairman of the State Administration Council always talked about 65 per cent of exchanging the currency whenever he met with MSME businesspersons or other businesspersons. He told businesspersons or industrial entrepreneurs that the exchange rate with Myanmar currency must be amended and reduced at an appropriate time. On 13 July, the CBM issued a press release that 50 per cent of earnings from export must be exchanged with Myanmar currency instead of 65 per cent. After that, everybody may notice that the trade process of the nation speeded up. Moreover, incomes from foreign exchange were higher in the market. The US dollar forex rate was more stable. At present, as twenty

thousand currency notes were published, we accept that rumours were spread to cause instability in situations. Importantly, I would like to inform such an issue and guarantee them the stability of the situation. The Q&A session of the CBM issued at about 9 am today was comprehensive.

However, it includes the technical terms and the public may understand it. What I want to say regarding this case is that... No 1, the K20,000-note is not issued in a large sum but it is just a commemorative note. Other countries had issued currency notes as a gesture of commemorative events. But, we have never made that before. We minted gold coins marking the 75th Diamond Jubilee Independence Day. At that time, although people can buy at fixed prices, they cannot purchase a lot. The current case is like that. Another fact is that it includes in the statement of the Central Bank of Myanmar (CBM). The new K-20,000 note is just a commemorative note and it will be granted if the people pay the equal value of note at the bank. There is also a limitation. If the people exchange their damaged notes with new K 20,000 notes worth K10 million at the bank, they will not be granted K10 million. One person can get only three K20,000 notes. These three notes will not be issued for free. As the saying goes, if one gives rice, he can get oil. The banknotes are aimed at exchanging damaged banknotes. The CBM will destroy all the damaged notes. Therefore, I am sure that it is completely impossible for new K20,000 notes to enter the financial market massively. I also guarantee that it will not happen. So, there will be no inflation. It spreads rumours to occur instability. The next fact is that the government also guarantees businesses in Section 36 of the Constitution. The government abides by the 2008 Constitution. It also assures with Section 36 (d) shall not nationalize economic enterprises and Section 36(f) shall not demonetize the currency legally in circulation. Therefore, we will not illegalize the officially issued currency as an illegal denomination. I also reaffirm that. The last one is that some are preparing to spread rumours in time regarding the current situation. The government can control these circumstances in business sectors. Therefore, what I want to inform the people is that they can operate for their socioeconomic development, and I guarantee it. Thank you.

In the press conference, the queries raised by the media outlets, on the distribution of the new "twenty-thousand-kyat" banknote, were responded as follows:

• The new banknote will be issued in a limited number in commemoration of significant events and will be distributed

only by exchange of the same value with various types of old banknotes that should not be appropriate for circulation. there will be no inflation.

• Old banknotes will be exchanged for "equal value" at the Central Bank of Myanmar in Nay Pyi Taw, the Yangon branch, and the Mandalay branch starting from 31 July on office days. One person can get only three K20,000 notes as a remembrance.

Moreover, the director general of the CBM U Win Myint explained in detail the

queries on the issuance of new banknotes in commemoration of significant events, further actions against speculation and manipulation on the distribution of the new twentythousand-kyat" banknote, and the required documents and provisions of the people when they exchange the new banknote at the banks.

The press conference was attended by the Director General of Financial Manage-

- During a period over three months from 1 April to 14 July, Myanmar exported 420,122.141 tonnes of varieties of pulses to foreign markets via sea route and 71,937.479 tonnes of pulses via border trade posts, earning a total of USD 389.82 million.
- During a six-month period from January to June, Myanmar had exported 275,584 fine rattan products and over 141,000 raw rattans.

• Moreover, Myanmar also exported 1.995 million bamboo sides, 4,000 bamboo sticks, and 18,000 bamboo mats during a six-month period from January to June.

The raw and fine products of rattan and bamboo were exported to foreign countries through border trade posts and maritime routes, it is reported.
